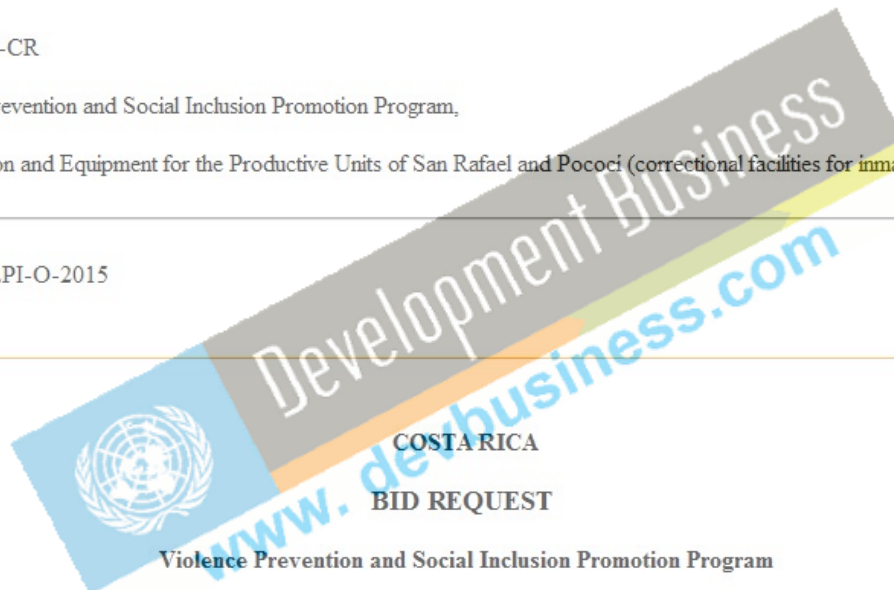

This international bidding notice is submitted as result of the general procurement announcement for this project, published in edition N° IDB1087-11/12 on November 14th, 2012.

The Government of Costa Rica has received a loan from the Inter-American Development Bank (IDB) to finance the Violence Prevention and Social Inclusion Promotion Program, and it has been suggested to utilize a portion of this Loan's funds to execute the payments stated on the Production Unit Equipment and Construction contract of the Production Unit in San Rafael and of the Production Unit of Pococi in Costa Rica. (Production Units are correctional facilities for inmates, where education and vocational training programs will be offered).

The bidding will be regulated by the eligible policies and procedures of the Inter-American Development Bank. The Executing Unit of the Program invites eligible parties to present sealed bids for the construction of the works mentioned below, in the following locations and details:

1. Batch 1, San Rafael Production Unit, province of Alajuela, canton of Alajuela, district San Rafael, construction area of 10.000 m², to be concluded within a period of 11 months starting at the date of notification of contract execution.
2. Batch 2, Pococi Production Unit, province of Limón, canton of Pococi, district Roxana, construction area of 10.000 m², to be concluded within a period of 11 months starting at the date of notification of contract execution.

The bidding will take place according to procedures of the international public bid, established in the Inter-American Development Bank edition, titled: Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN 2349-7 and it is open to bidders from all the countries that are specified in such policies.

The eligible interested bidders, may request additional information and retrieve the documents of the bidding at the Executive Unit Program, in the address stated at the end of this document (of the Executive Unit Program) starting October 13th, 2015, during opening hours from 7:30 am to 3:30 pm. Access can also be requested to withdraw a complete package of the documents of the bid in Spanish, via email at adquisiciones@uep-mjp.go.cr at no additional cost. Either if the documents are withdrawn from the Executive Unit headquarters or a request is made via email the candidate should provide an email address to receive its notifications during the process.

Quotes shall be sent to the Executive Unit Program no later than November 25th, 2015 at 2:00 pm local time. All bids shall be accompanied by a Bid bond for US\$ 250.000,00, complying with the format specified on Section I. (Guarantee Forms). Bids submitted afterhours will be declined. Bids will be opened in the presence of the bidders' representatives and all other persons who want to attend, at the Executive Unit Program Headquarters on November 25th, 2015, at 2:00 pm Costa Rica time.

An informative meeting will take place at 9:00 am, on October 23th, 2015 at the Costa Rica Country Office of the Inter-American Development Bank, located at Centro Corporativo El Cedral, Torre 1, Piso 2, Escazú, San Jose, Costa Rica. All the interested companies should confirm attendance at least 4 working days prior via email at adquisiciones@uep-mjp.go.cr.

If companies non established in Costa Rica are not able to travel to attend the meeting, they may participate by video-conference from the IDB's country offices; access to the Bank's videoconferencing facilities shall be requested with a minimum notice of 4 working days by contacting Mauricio Martinez at mjmartinez@iadb.org. A visit of each construction site is also proposed. They will take place on:

1. San Rafael Production Unit, October 28th, 2015, at 9:00 am,
2. Pococi Production Unit, October 29th, 2015, at 9:00 am,
