The Ministry of Education, Youth and Sports (MOEYS) has received financing from the Inter-American Development Bank (IDB) toward the cost of the Education Quality Improvement Project, and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include Consultancy Services to Develop and Implement a Communication Strategy for attracting Higher Quality Teacher Training Candidates and for Promoting the EQIP Program Components and Sub-components.

The Education Quality Improvement Project (EQIP) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank GN-2350-9 and is open to all eligible bidders as defined in the policies.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the short list, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of Joint Venture, the nationality of the firm appointed to represent it.

A Consultant will be selected in accordance with the Fixed Budget Selection method set out in the Consultant Policies.
