Design and Implementation of a Public Awareness Communication Campaign for Birth Name Insertion for the Registrar General's Department, Ministry of the Attorney General and Legal Affairs, Government of the Republic of Trinidad and Tobago (GORTT), Inter-American Development Bank (IDB) Loan No. 3022/OC-TT

The Ministry of the Attorney General and Legal Affairs through the Registrar General's Department has embarked upon an initiative towards improving the services offered to citizens of Trinidad and Tobago. Funding for this project has been provided by the Inter-American Development Bank - Loan No. 3022/OC-TT.

The Registrar General's Department holds the responsibility for the registration of all civil, land and company records and is the sole custodian of these records. With primary focus directed to its land registration system, the Ministry will be utilizing this funding to undertake the project - Strengthened Information Management at the Registrar General's Department.

As part of the overall project the Registrar General's Department is seeking to contract a suitably qualified and experienced consulting firm to undertake work associated with the design and implementation of a public awareness communication campaign for birth name insertion for the Registrar General's Department, Ministry of the Attorney General and Legal Affairs.

Currently it is estimated that there are at least 280,000 persons whose names do not appear on their national birth certificates. These persons have been identified primarily as occupying the southern areas of Trinidad & Tobago and are above the age of fifty (50). As an interim measure these persons continue to swear affidavits to validate their first names and consequentially create the opportunity for fraud. This information forms a fundamental component within the overall project landscape, the acquisition of which has been identified as a key objective.

The Public Awareness Communication Campaign is required to encourage the improvement of birth registration information.

Bidding documents may be obtained from Monday to Friday during office hours 8:00 a.m. to 4:00 p.m. local time at the Central Tenders Board's Office, at address (1) below.

A pre-bid meeting will be held for prospective bidders on Friday 18th November, 2016 at 10:00 a.m. on the 3rd Floor of the Registrar General's Department, Registration House, 72-74 South Quay, Port of Spain.

Any further technical information can be obtained from address (2) below from Monday to Friday during office hours 7:00 a.m. to 3:00 p.m. local time.

Proposals must be accompanied by the following:

- (i) Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date for submission of proposals. (Local firms)
- (ii) Valid Certificate of Compliance issued in accordance with the National Insurance Act. (Local firms)
