This international bidding notice was announced under the General Procurement notice advertised for this project published in Development Business Online, edition No. IDB880-805/11 of 15 August 2011.

The Republic of Suriname has received financing from the Inter American Development Bank (IDB) and it intends to apply part of the proceeds to payments under the project Water Supply Infrastructure Rehabilitation for purchasing digital water meters and portable flow meters.

The N.V. Surinaamsche Waterleiding Maatschappij now invites sealed bids from eligible bidders for the delivery of digital water meters and Portable watermeters. The delivery period is 90 days.

Bidding will be conducted through International Competitive Bidding procedures as specified in the Inter American Development Bank's [Policies for Procurement of Works and Goods financed by the Inter American Development Bank](#) (current edition), and is open to all eligible bidders as defined in the policies.
