The *Republic of Suriname* has received financing from the *Inter-American Development Bank (IDB)*, toward the cost of the *Support for the Implementation of the EBS Investment Plan*, and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include *support (design, develop, implement, coordinate and facilitate) for the organizational restructuring of the N.V. EBS to comply with the Electricity Act 2016 resulting in a fit-for-purpose organizational model to improve the overall performance of N.V. EBS.*

The *N.V. Energiebedrijven Suriname* now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank *Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank* GN-2350-9 and is open to all eligible bidders as defined in the policies.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the short list, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of Joint Venture, the nationality of the firm appointed to represent it.

A Consultant will be selected in accordance with the *Quality & Cost Based (QCBS)* method set out in the Consultant Policies.
