## SPECIFIC PROCUREMENT NOTICE

The Government of the Republic of Trinidad and Tobago has received a total of Fifty Million Dollars (US \$ 50,000,000.00) financing from the Inter-American Development Bank (IDB) toward the cost of the 'Wastewater Infrastructure Rehabilitation Program. The Borrower intends to apply a portion of these funds to eligible payments under this Program. These funds will be allocated to various projects as follows:

- Design and Construction of Trincity Wastewater Treatment Plant;
- Construction of Two (2) Sewerage Systems in South West Tobago;
- c. Provision of Consultancy Services to Conduct Detailed Designs and Preparation of Tender Documents for the Maloney Wastewater Treatment Plant and Phase Two (2) Collection System

The general objective of the Program is to improve the environmental conditions of Trinidad and Tobago by increasing the volume of wastewater treated. The specific objectives of the Program are: the takeover, refurbishment, upgrade, integration or decommissioning of malfunctioning private wastewater treatment facilities and the improvement of WASA's wastewater management and operational and maintenance performance.

The Water and Sewerage Authority now invites sealed bids from eligible bidders for the Design and Construction of the Trincity Wastewater Treatment Plant to be funded under the Wastewater Infrastructure Improvement Program. This procurement process requires bidders to have the following specific experience and/or capabilities:

- Wastewater treatment process design
  - Wastewater collection system design (inclusive of pumping stations, forcemain, gravity sewers etc.)
- Civil/Structural works
- Mechanical works
- Electrical, SCADA, Instrumentation and Control works
- General Project Administration
- Customer Relations and Stakeholder Management
- Water Quality Monitoring
- Operation and Maintenance Plan Development and Training
- Site Management, Quality Control and Health and Safety

The period for construction works is twenty-four (24) months.

Ridding will be conducted through international competitive hidding procedures as specified in the Inter American Development Rank's Delicies for

Procurement of Works and Goods financed by the Inter-American Development Bank (current edition), and is open to all eligible bidders as defined in the policies.

Interested respondents will have the opportunity to view the tender documents at the Purchasing Department, WASA Head Office. Documents would be issued via email upon presentation of a receipt showing a non-refundable fee of **Four Thousand T.T. Dollars (TT\$ 4,000.00)** or **Six Hundred and Ten US Dollars (US\$610.00)** has been paid to the Authority's Cashier, Farm Road, St. Joseph. All bids must be delivered to the address stated at the end of the document at or before 2:00 pm on 21<sup>st</sup> September 2018.
