SUPPORT FOR A NATIONAL AVIATION MASTER PLAN

The Government of the Cooperative Republic of Guyana has received financing from the Inter-American Development Bank (IDB), toward the cost of the preparation of a National Civil Aviation Master Plan and intends to apply part of the proceeds for consulting services.

The executing agency is the Guyana Civil Aviation Authority (GCAA). The consulting services ("the Services") include preparing a National Civil Aviation Master Plan (CAMP) that will guide the Government of the Cooperative Republic of Guyana in the orderly development of Guyana's Air Transport Sector. Specifically, the following components are expected to be addressed: a National Air Transport Master Plan; a National Airspace Master Plan; a National Airports Master Plan; a Civil Aviation Authority Master Plan; a discrete Corporate Plan with Legislative and Organizational Framework for an Airports Authority; and a discrete Business Case for the Airports selected for development, with implementation strategies.

The consultancy will require the services of an international consulting firm with extensive experience in the air sector, focusing in air sector policy. It is essential that the consulting firm demonstrate experience working on such studies in developing countries particularly in the Caribbean and Latin America. At a minimum the team shall consist of an aviation planner/air transport economist, financial analyst, legal consultant and an environmental consultant. The estimated implementation period of the Consultancy is ten (10) months. The Guyana Civil Aviation Authority (GCAA) now invites eligible consulting firms

("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank GN-2350-9 and is open to all eligible bidders as defined in the policies.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Policies.
