The Ministry of Finance of the Commonwealth of The Bahamas has received financing from the Inter-American Development Bank (IDB), and intends to apply part of the proceeds to payments under the Citizen Security and Justice Project for a consultant to **Deliver Training in Techniques for Rehabilitative Corrections and Social Reintegration for Officers working with Juveniles in Conflict with the Law**

Main Responsibilities of the Consultancy:

- Develop a Training Portfolio
- Conduct pre and post training assessments of officers' knowledge, attitude, and level of acceptance of the principles and practice of human rights based correctional philosophy, psychology-based practices for managing juveniles in conflict with the law
- Deliver training seminars on the principles of human rights based correctional philosophy, psychology and practices for managing juveniles in detention for 600 corrections officers and 24 juvenile rehabilitation personnel

The Government of The Commonwealth of The Bahamas now invites eligible consultants to indicate their interest in providing the services. Interested consultants should provide information demonstrating that they are qualified to perform the services (brochures, description of exact or similar assignments, and experience in similar conditions.) Consultants may associate to enhance their qualifications. **The work period for the consultancy will be spread out over a 12 month period with one training month in the Fall of 2019, one in the Spring of 2020 and the other in the Fall of 2020.**

Consultants should have a Ph.D. and will be selected in accordance with the procedures set out in the Inter-American Development Bank: Policies for the Selection and Contracting of Consultants Financed by the Inter-American Development Bank GN-2350-9 is open to all eligible bidders as defined in the policies.
