

Technical Cooperation

As part of INTAL's 2004 Work Program, the Institute for the Integration of Latin America & the Caribbean (INTAL) set about the task of following up projects still ongoing or initiated during 2004. These are part of the sum total of projects initated since July 1996, including those funded with resources from the INTAL Contribution Fund. This also lent continuity to the implementation of the Associated Technical Cooperations that the Fund had been developing as part of its activities program.

The objectives and activities promoted through ongoing regional technical cooperation operations and associated technical cooperations, including projects ending in 2004, are outlined below.

INTAL Contribution Fund (Project Document 552/04): 'INTAL's Management in the Administration of the General Fund of Projects Funded by Member Country Contributions'. **Objectives:** The project aims to fund the external audit services of the General Project Fund funded with Member Country Contributions. **Activities:** Activities involve producing an audit examination and the subsequent publication of a report on the administration of these resources.

INTAL Contribution Fund (Project Document 551/04): 'Latin America/Asia-Pacific Relations'. **Objectives:** The project's main objective is to support relations and foster cooperation between Latin America and Asia, while sponsoring the development of research and dissemination activities around interregional relations, and thus contribute to public and private strategy and policy-making and implementation in this area. **Activities:** The project has three components: 1) Follow-up and monitoring of the activities of Forum Latin America East Asia Cooperation (FEALAC), the Latin America/Caribbean & Asia/Pacific Economics & Business Association (LAEBA), and cooperation with the Latin American and the Caribbean Studies Network on Asia-Pacific (REDEALAP); 2) Consolidation of REDEALAP in support of the management of FEALAC and LAEBA; and 3) Research into the internationalization process of the Chinese Economic Groups (*Jituangongsi*) to define strategies for MERCOSUR and Andean Countries member countries. These activities are being performed by contracting consulting services.

INTAL Contribution Fund (Project Document 550/04): 'Landmarks in Latin American Integration'. **Objectives:** The project aims to support the development of research and dissemination activities into the historical process of Latin American integration as being of technical value in meeting the process's current challenges at bilateral, subregional, regional, hemispheric, interregional and multilateral levels. **Activities:** The project involves three specific activities: 1) a publication on *The History of Latin American Economic Integration: The*

LAFTA/LAIA Process 1950-1999 to be prepared with the Latin American Integration Association (LAIA); 2) a publication summarizing the academic contributions of Fernando Fajnzylber over his distinguished career at the Economic Commission for Latin America & the Caribbean (ECLAC) to be prepared in tandem with the ECLAC; 3) a tribute to and publication of the work of Germánico Salgado. Tribute and publication will be performed in tandem with the General Secretariat of the Andean Community, as part of INTAL's preparations for its 40th Anniversary in 2005.

INTAL Contribution Fund (Project Document 549/04): 'Training in Computable General Equilibrium (CGE) Models for South American Countries'. Objectives: The project's main aim is to organize an intensive short course to provide basic and intermediate training in techniques of CGE trade policy modelling and its application for 24 officials involved in trade negotiations by Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Paraguay, Peru, Uruguay and Venezuela. To this end, the Bank put out a call for proposals which were subsequently presented and analyzed. After the evaluation process, the proposal by Global Trade Analysis Project (GTAP) of Purdue University was selected in view of their experience in similar projects at the global level. Activities: The course was held in the INTAL Auditorium between May 8 and 14, 2004. The activities were divided into two parts: the first consisted of a preliminary training course on the World Wide Web, enabling participants to familiarize themselves with GTAP theory and software. The second part of the course, attended in person, lasted seven days, and consisted of a combination of reading texts, laboratory tasks and informal discussions introducing participants to basic aspects of the CGE model and database. The activities culminated in a practical exercise conducted by small groups of participants overthe last day. Two instructors were assigned to each of the groups to act as facilitators. Participants left the course qualified to design, conduct and analyze their own equilibrium models simulations.

INTAL Contribution Fund (Project Document 547/03): 'Support for the Institutional Operations of the Initiative for Regional Infrastructure Integration of South America'. **Objectives:** The project aims to support the institutional operations of the Iniciativa para la Integración de la Infraestructura Regional Suramericana (IIRSA: Initiative for Regional Infrastructure Integration of South America) through logistical and administrative support for its management as per the Meeting of Heads of State and Government of South American Countries (Reunión de Jefes de Estado y Gobierno de América del Sur) in September 2000 in Brasilia. **Activities:** Activities in this project involved the institutional management of the Initiative at the logistical and administrative levels in relation to the hiring of services to the Secretariat's technical and administrative tasks. The project was funded jointly by the three institutions making up the Comité de Coordinación Técnica (CCT: Technical Coordination Committee), namely the Inter-American Development Bank (IDB), the Corporación Andina de Fomento (CAF: Andean Development Corporation) and Fondo Financiero para el Desarrollo de la Cuenca del Plata (FONPLATA: Financial Fund for the Development of the River Plate Basin).

INTAL Contribution Fund (Project Document 543/02): 'Design of INTAL Structure & Procedures'. **Objectives:** The project aims to support compliance with the recommendations regarding INTAL's operational and administrative needs in accordance with the report by the Bank's Auditor General on Review of INTAL Operational and Administrative Activities. **Activities:** A computerized system was designed and implemented for the accounting and

budgetary administration of technical cooperation projects. A basic structure of formal organization was defined for INTAL to meet its operational and administrative needs, in compliance with the basic principles of administration and the Bank's goals. A manual of accounting, administrative and budgetary control procedures for INTAL was then introduced.

ATN/SF-8933-RE (Project CTR-101/04-REG): 'Training Program in Trade Negotiations in the WTO'. **Objectives:** The project aims to continue strengthening the negotiating and agreement implementation capability of Latin American and Caribbean governments in line with the rules and disciplines issued by the World Trade Organization for practical deployment in national, bilateral, subregional, hemispheric, interregional and multilateral environments. **Activities:** The agenda of activities envisaged for 2005-2007 includes workshop/courses on a variety of areas of trade negotiation and agreement implementation involving negotiators from right across Latin America and the Caribbean. Priority areas approached in the project include: Anti-dumping and Compensation Rights Calculation; Customs Valuation; Investments; Competition Defense; Intellectual Property; Negotiation Techniques & Mechanisms; Agriculture; Sanitary & Phytosanitary Measures; Dispute Resolution; Trade Policy Review; Trade Facilitation; Subsidies; Services; Trade & the Environment, and Government Procurement.

ATN/SF-8933-RE (Project CTR-102/04-REG): 'Training Program in Trade Negotiations'. **Objectives:** The project aims to contribute to the formation of capabilities relating to negotiations and agreements on integration and trade in civil society in Latin America and the Caribbean, and, at the level of the governments, to the critical analysis of key subjects impacting current subregional processes. Unlike the training program conducted with the WTO, the content of these activities for government and non-government representatives took a critical approach to the subjects deemed most important by the governments, with the contribution of instructors from the private or academic sphere, or from other regional and international bodies. This approach went beyond the fields of formal debate and contributed in a differentiated way to positioning design in fields considered strategic not only by the region's governments, but also by the representatives of civil society in general. Activities: Activities in this project included subregional workshop/courses on a variety of areas of trade and agreement implementation negotiation involving representatives of civil society and teams of negotiators from all parts of Latin America and the Caribbean. The priority areas were defined with the participating governments or interest groups on the basis of the balance sheet and relevance of the subjects for each subregional area. This embraced sectoral aspects and subjects belonging to the corresponding subregional process, as well as the interrelation and impact on the process of the other bilateral, hemispheric, interregional and multilateral scenarios.

ATN/SF-8933-RE (**Project CTR-103/04-REG**): 'INTAL/Andean Community Internships Program'. **Objectives:** The objective of this program is to promote knowledge of the principles and advances of Andean integration and internationalization of Andean economies, and to familiarize to professionals from the member countries with the Community's workings to facilitate the process in which the subregion is involved via a training mechanism. **Activities:** Internships for young professionals from member countries were continued at the headquarters of the Sede de la Secretaría General de la Comunidad Andina (General Secretariat of the Andean Community). These internships imparted a theoretical formation, including Andean integration strategies and other experiences, as well as the structure and features of the Andean Community in order to produce direct knowledge about the way the Community works and its different fields. The internship ended with a specific work on one of the Community's areas, enabling the internee to extend and put into practice the knowledge acquired.

ATN/SF-8933-RE (Project CTR-104/04-REG): 'Analysis of the National Trade Policy-Making Process'. Objectives: The project aims to reach an understanding of the internal processes in international trade policy-making in the countries of the Western Hemisphere. More specifically, it attempts to determine whether the participation of non-government organizations (NGOs) and other representative groups from civil society in each country is possible, and what the most appropriate procedure is. Activities: Activities consist of drafting a series of technical reports one per country-answering a variety of questions, such as whether there are established inquiry procedures on trade policy-related subjects in each country; whether these procedures are transparent and the information is available to the public and the press; what groups will be included in the inquiry process (companies, chambers of commerce, the agricultural sector, NGOs, universities, etc.); what the nature and structure of the inquiry plan will be like. Subsequently a series of memoranda will be drafted to answer these queries, and will be presented and discussed in workshops in each of the authors' countries of origin. The authors will then be invited to review their reports taking into account what has been analyzed and discussed in the workshops. Finally the material produced will be published. The project is executed in tandem with Inter-American Dialogue, the University of Toronto and the IDB's División de Integración, Comercio y Asuntos Hemisféricos (Integration, Trade & Hemispheric Issues Division).

ATN/SF-8933-RE (Project CTR-201/04-REG): 'Backing for Research Networks in Support of Policy Reforms'. Objectives: The project aims to support the strengthening of research capability in subjects relating to the field of integration in Latin America and the Caribbean. Activities: Academic research is undertaken along four lines of action: a call for papers by the Red INTAL de Centros de Investigación en Integración (RedINT: Network of Research Centers on Integration); the activities of the Euro-Latin Study American Network on Integration & Trade (ELSNIT), the Latin America/Caribbean & Asia/Pacific Economics & Business Association (LAEBA), and the INTAL Award's academic competition. For RedINT, the call is directed at research institutions or individual researchers from the Latin American Countries and the Caribbean; for Centers, individually or through consortia, as applicable. The possibility of forming consortia is designed to facilitate the complementation of experiences in the subject under study, as well as for the specific lessons arising from the analysis in the respective countries of each subregion. With regard to ELSNIT and LAEBA, support for these initiatives will be defined specifically once the respective work programs for the period 2005-2006 have been designed and implemented. It should be stressed that this project will support the hiring of research selected on the basis of the development of both undertakings. The definition of these aspects will be made jointly with the IDB's Integration, Trade & Hemispheric Issues Division, and in the case of ELSNIT, its Special Office in Europe. The call for papers for the INTAL Award will be held in 2005, and as in previous cases, the winner of the Award will receive a sum of money as recognition for his or her academic work, and a commemorative gift of the competition. Between three and five special mentions will also be made, whose winners will receive a statuette or commemorative medallion.

ATN/SF-8933-RE (Project CTR-301/04-REG): 'Workshops, Forums & Special Events'. **Objectives:** The project aims to support the analysis and dissemination of subjects relating to integration and trade in Latin America and the Caribbean in order to generate policy recommendations in the public and private sectors, while promoting knowledge and awareness about the subject in the area of civil society. **Activities:** Activities envisaged for development of the project include any work necessary for the organization of workshops, forums and special events, such as hiring experts for the preparation of studies to serve as a basis for debate, as well as consultants responsible for follow-up and coordination of logistical and technical aspects, travel for participants selected, organization and logistical support (sound, translation, communications, etc.), preparation and issue of documents.

ATN/SF-8933-RE (Project CTR-302/04-REG): 'INTAL Publications'. Objectives: The project aims to promote, through a group of publications, the dissemination of specialist studies, articles, information and ideas relating to ongoing or planned integration processes in Latin America and the Caribbean. Activities: The INTAL publications to be supported via the project are divided along the following lines of action: (i) the Integration & Trade Journal, a semi-annual publication issued in Spanish and English; (ii) the INTAL Monthly Newsletter, a monthly publication to be published in Spanish, Portuguese and English; (iii) Dissemination and Working Papers, and the INTAL-ITD Series, represented by works specializing in the field of regional integration; (iv) Special Reports on the Development of the Regional Integrationist Process, consisting of works published sequentially as an updating instrument on the development of ongoing and planned integration schemes in Latin America and the Caribbean, and at the hemispheric level. Regarding the last mentioned group, attention should be drawn to the issue of MERCOSUR, Andean, Central American and Caribbean Reports, as well as Reports resulting from the call for papers by the Red INTAL de Centros de Investigación en Integración (RedINT: Network of Research Centers on Integration). Also, in terms of activities generated along INTAL's remaining lines of action (forums, seminars, regional technical cooperation, etc.), special editions of publications were prepared. The project helped to cover the costs of compilation, preparation and content analysis, evaluation and selection of articles, design and publication, translation, printing, and distribution and commercialization of the publications outlined previously.

ATN/SF-8933-RE (**Project CTR-303/04-REG**): 'Database & Documentation Services'. **Objectives:** The project aims to promote the dissemination of specialist bibliographies, studies, regulatory or any other type of information relating to ongoing or planned integration processes in Latin America and the Caribbean through the activities of INTAL's Centro de Documentación y Biblioteca (CDI: Center for Documentation, Information Systems & Databases). Also, the historical and geographical coverage of DATAINTAL and other databases was further updated and broadened, as was the Institute's web page. Activities: The CDI covers information dissemination and bibliography in the field of integration and trade through a strategy enabling it to form a cooperative regional information center. Through this project, the CDI has made available the resources necessary to continue developing the actions aimed at the executing the envisaged strategy. Among the most prominent tasks scheduled for the project's execution period was the broadening of the INTAL's Publications Catalog, and the broadening and improvement of systems design that will facilitate regional projection of the CDI's activities, especially over the Internet. INTAL is web site was also updated in the framework of this component. INTAL has

been playing a an ever more important role in the information field. Examples of this line of action are represented by the Base de Estadísticas de Comercio Exterior (DATAINTAL: Foreign Trade Statistics Database), the Base INTAL-MERCOSUR (BIM: INTAL-MERCOSUR Databse), and the legal integration treaties and instruments database. Despite the design, operation and maintenance of these and other new databases, implemented in some cases through other projects, the systems support update and adaptation of the CDI bibliographic database were supported by this project. Attention should be drawn to the update and maintenance of the Institute's web page in this field. The DATAINTAL system was pursued via new versions of the ones already available on the Internet and CD-ROM to facilitate access to the system by regional and extraregional economic agents. The update and maintenance of DATAINTAL may continue to involve the hiring of specialist consultants.

ATN/SF-8120-RE (Project CTR-101/03-REG): 'Academic Research in the Field of Integration'. **Objectives:** The project aims to support the strengthening of research capability in the field of integration. Activities: Academic research is undertaken along four lines of action: a call for papers of the Red INTAL de Centros de Investigación en Integración (RedINT: Network of Research Centers on Integration) directed at Latin American and Caribbean research Institutions, individually or through consortia as applicable; the activities of the Euro-Latin Study American Network on Integration & Trade (ELSNIT) launched in tandem with the Special Office in Europe and the División de Integración, Comercio y Asuntos Hemisféricos (Integration, Trade & Hemispheric Issues Division) of the Integration & Regional Programs Department. The initiative creates a forum on subjects of integration and trade in Europe relevant for Latin America and the Caribbean. Its main objectives are to generate research, studies and debate on these subjects, and thus increase interaction between researchers from both regions; the Latin America/Caribbean & Asia/Pacific Economics & Business Association (LAEBA), an initiative launched jointly by the IDB and the Asian Development Bank (ADB) devoted to strengthening ties between both regions through a series of activities, including research and exchange of experiences between both regions; and lastly, the INTAL Award's academic competition for professionals and/or academics from Bank member countries whose works contribute to the study of regional and hemispheric integration processes.

ATN/SF-8120-RE (Project CTR-102/03-REG): 'Support for the Trade Negotiations for Latin America and the Caribbean'. **Objectives:** The project aims to continue strengthening the negotiating capability of Latin American and Caribbean Governments regarding the rules and disciplines issued by the World Trade Organization for practical deployment in subregional, hemispheric and multilateral environments. **Activities:** The agenda of activities includes workshop/courses on a variety of priority areas for trade negotiations including antidumping and compensation rights, customs valuation, investments, competition defense, intellectual property, agriculture, dispute resolution, trade facilitation, and government procurement.

ATN/SF-8120-RE (**Project CTR-103/03-REG**): 'Andean Community/INTAL Internship Program'. **Objectives:** The objective of this Program is to promote knowledge of the principles and advances of Andean integration and the internationalization of Andean economies, and, via a training mechanism, to familiarize professionals of the member countries with the workings of the Community to facilitate the process in which the subregion is involved. **Activities**: To achieve this goal, internships for young professionals from the member countries continued to be held at the headquarters of the General Secretariat of the Andean Community. These internships imparted a theoretical formation, including Andean integration strategies and other experiences, as well as the structure and features of the Andean Community in order to produce direct knowledge about the way the Community works and its different fields. The internship ended with a specific work on one of the Community's areas, enabling the internee to extend and put into practice the knowledge acquired.

ATN/SF-8120-RE (Project CTR-202/03-REG): 'Policy Forums & Special Events'. **Objectives:** The project aims to support the analysis and dissemination of subjects dealing with integration and trade in Latin America and the Caribbean in order to produce policy recommendations on them at the level of the public and private sectors, as well as furthering the increase of knowledge and awareness on this subject at the level of civil society. **Activities:** Activities envisaged include any work necessary for the organization of Policy Forums and Special Events. Included in this is the hiring of experts for the preparation of studies to serve as a basis for debate in the forums and events, travel for participants selected from the public and private sectors, organization and logistical support, preparation and issue of documents relating to the forums/events.

ATN/SF-8120-RE (**Project CTR-203/03-REG**): 'INTAL's Center for Documentation, Information Systems & Databases'. **Objectives:** The project aims to promote the dissemination of specialist bibliography, studies, regulatory or other kind of information to do with ongoing or planned integration processes in Latin America and the Caribbean through the activities of INTAL's Centro de Documentación y Biblioteca (CDI: Center for Documentation, Information Systems & Databases). Also, the historical and geographical coverage of DATAINTAL and other databases was further updated and broadened, as was the Institute's web page. Activities: Activities were developed through the Centro de Documentación y Biblioteca (CDI: Center for Documentation, Information Systems & Databases), and disseminated integration and traderelated information and bibliography through a strategy enabling it to form a cooperative regional information center. As mentioned above, other activities included updating the DATAINTAL database and web page.

ATN/SF-8120-RE (**Project CTR-204/03-REG**): 'INTAL Publications'. **Objectives:** The objective of the project is to promote the dissemination of specialist studies, articles, information and ideas relating to ongoing or planned integration processes in Latin America and the Caribbean through a group of publications. **Activities:** Activities developed through this project were undertaken along the following lines of action: (i) publication of the *Integration & Trade* Journal; (ii) publication of INTAL's Monthly Newsletter; (iii) publication of Dissemination and Working Papers, and the INTAL-ITD Series; (iv) publication of Special Reports on the Development of the Regional Integrationist Process, including the Andean, Caribbean, Central American and MERCOSUR Reports, and others resulting from the call for papers of the Red INTAL de Centros de Investigación en Integración (RedINT: Network of Research Centers on Integration). Also, special editions of publications were prepared in terms of activities generated through forums, seminars or regional technical cooperations.

Associated Technical Cooperation (CTA 013/03-RG) (ATN/SF-8142-RG): 'Support for Program of Trade Policy Strengthening in the Andean Community'. **Objectives:** The objective of

this regional technical cooperation is to promote the strengthening of the institutional capability of the governments of Andean Community countries in terms of the formulation of their foreign trade policy, especially in the framework of the multilateral agenda of trade negotiations in the World Trade Organization. Activities: Project-related activities consisted of the three training courses lasting approximately five days each on the subject of Anti-Dumping, Subsidies and Competition, and Agriculture and Services. The courses targeted specialists in trade negotiations from Andean Community Countries selected by the respective Governments, with the participation of approximately three officials from each of the Andean countries.

Associated Technical Cooperation (CTA 012/02-MER) (LOAN 1279/OC-AR): 'Institutional Strengthening Program of the Ministry of Foreign Relations, International Trade & Worship'. Objectives: The objective of this project was to provide technical support for the MRECIC's Institutional Strengthening Program for activities involving the hiring of consulting services and organization of training activities in accordance with the Loan Agreement signed by the Argentinian Government and the Inter-American Development Bank. Activities: INTAL played the role of technical assistant in the Program in relation to the development of the works listed below in support of the administration of the Program Execution Unit (PEU) based at the Ministerio de Relaciones Exteriores, Comercio Internacional y Culto (MRECIC: Ministry of Foreign Relations, International Trade & Worship) of the Republic of Argentina. The components of the program in which INTAL took part are: (i) revision of the consultant shortlists and/or process to call for bids for professional services; (ii) presentation before the PEU of non-objection to the consultant shortlists for subsequent submission to the IDB; and (iii) supporting the PEU in organizing and carrying out training and dissemination activities. INTAL's technical support was made in tandem with the Bank's Representation in Argentina.

Associated Technical Cooperation (CTA 010/01-RG) (ATN/SF-7775-RG): 'Support Project for the Plan of Action for Regional Infrastructure Integration in South America'. Objectives: The objective of this technical cooperation is to support the establishment of a process enabling the governments of South American countries to make coordinated decisions in order to: (i) make progress in the development of regional physical infrastructure in the areas of transport, communications and energy; and (ii) to improve and harmonize their regulatory frameworks. The projects emerging from this process must have the active participation of the private sector in their financing, while also protecting the environment and fostering integral social development. Activities: The project included four groups of activities: (1) Support for the Executive Technical Groups (ETGs) through the hiring of specialist consultants consisting, highly qualified professionals in the areas of transport, communications and energy who coordinate and provide the Executive Technical Groups (GTEs) with technical support for sectoral integration foci and processes; (2) Logistical support for the IIRSA Secretariat and organization of meetings and seminars through the hiring of one professional and two assistants for the Secretariat's administration, and the design and update of the Initiative's page web; (3) Specific technical studies on regional infrastructure integration through the financing of: (a) consultancy for the preparation of diagnostic and methodological studies on financial, economic, environmental and risk aspects relating to possible infrastructure projects or regulatory framework harmonization identified by the Initiative and, (b) mechanisms for the dissemination of the results of the studies via publication or electronic distribution; (4) Evaluation of the institution's contribution to the execution of the project's activities by an independent consultant.

Associated Technical Cooperation (CTA 008/01-MER) (LOAN 1206/OC-AR): 'Institutional Strengthening Program for the Formulation of the Argentinian Republic's Foreign Trade Policy'. Objectives: The objective of this project was to offer technical and administrative support for activities involving the hiring of consulting services and organization of training activities in accordance with the Loan Agreement signed between the Government of the Argentinian Republic and the Inter-American Development Bank. Activities: INTAL played the role of technical and administrative adviser for the development of the Program in connection with the works on the components indicated below, in support of the management of the Executive Program Unit (EPU) based at the Argentinian Republic's Ministry of Economy. The components of the program in which INTAL participated are as follows: (i) Institutional strengthening; and (ii) Interrelation of trade policy with the private sector and provincial entities of the public sector. INTAL's technical and administrative support was provided in coordination with the Bank's Representatives in Argentina.

Associated Technical Cooperation (CTA 007/00-MER) (ATN/SF-7287-RG): 'Unfair Trade Practices in MERCOSUR'. Objectives: The project's objective was to contribute to the deepening of MERCOSUR's integration process by improving the instruments of protection against unfair trade practices and ensuring their appropriate application. Activities: The project involved activities aimed at creating proposals for improvement in the field based on the rules of the Regulations for the Defense against Dumping Imports from countries not members of MERCOSUR, the development of the Common Regulation on Subsidies; and the transfer of experiences from the North American Free Trade Agreement (NAFTA) to MERCOSUR. Cooperation between NAFTA and MERCOSUR concentrated on strengthening the application of research techniques and subsidy calculation, selecting for this an entity/agency from a NAFTA country with vast experience in the subject. The project was concluded during the 2004.

All the above technical cooperation operations were jointly executed with the Bank's División de Integración, Comercio y Asuntos Hemisféricos (Integration, Trade & Hemispheric Issues Division), as well as other of the institution's units, as indicated for each case.

Policy Forums & Special Events

Policy Forums and Special Events are meetings to discuss and debate integration with the active participation and leading role of the private sector, including representatives of the business and labor sectors, and non-government organizations (NGOs), as well as public authorities, subregional integration bodies and experts on the subjects dealt with at each meeting. These events gave rise to a significant number of documents that were circulated in book form, on CD-ROM and in papers, and via the INTAL and other institutions' web pages. A detailed listing of forums and events are presented in a summary chart later on in this report.

The Policy Forums carried out by INTAL dealt with the opportunities and challenges of trade negotiations for Latin America and the Caribbean. Multilateral meetings were held at the level of the World Trade Organization (WTO), and other meetings focused on the hemispheric scenario and the state of development of subregional integration. Special emphasis was placed on analyzing the processes participation and consultation with civil society at the national and

regional levels, an issue of particular importance as part of the need to legitimate the scope and content of the agreements under negotiation. More specifically, discussions were held about certain challenges in such areas as rules of origin, direct foreign investment and the fiscal impact of integration, and its influence on the design of tax reforms required to meet this challenge.

In addition, other areas relating to the promotion of cooperation activities between countries in the region were given special interest. First, analyses were made of possible cooperation actions in the framework of regional or subregional financial safety nets designed to mitigate the effects of external shocks on the economies of Latin America and the Caribbean. Second, analyses were made of the scope and content of possible regional or subregional cooperation actions regarding social policy and policy designed to mitigate current levels of poverty and inequality. Last, several meetings focused on the design of strategies of approach, research and information dissemination about interregional relations between Latin America and the Caribbean & Asia/Pacific Economics & Business Association (LAEBA) and Euro-Latin Study American Network on Integration & Trade (ELSNIT). These events attracted large audiences and produced a variety of technical documents published and disseminated by the Institute through their web page.

In addition to policy forums and special events organized by INTAL, officials from the Institute took part in seminars and conferences on a variety of subjects relating to the Institute's field of action, as shown in the summary chart below.

Information Dissemination

The three lines of action carried out by INTAL in this area are: the services of INTAL's Centro de Documentación y Biblioteca (CDI: Center for Documentation, Information Systems & Databases), the preparation and update of databases and other information systems, and the Institute's publications.

Over the course of 2004, the CDI received a large number of inquiries, which break down as follows.



Inquiry of Virtual Users

24,737 inquiries were made on the CDI web site and for files produced by the Center. This is 10% down on 2003. It should be stressed that, for several reasons, the statistical figures for virtual users are estimates:

• *The information used was not available in the following weeks:*

- January: from 18 to 24 (1 week)
- July: from 18 to 24 (1 week)
- August: from 8 to 21 (2 weeks)
- October: from 26 to 1/11 (1 week)
- November: from 7 to 13 (1 week)
- December: from 20 to 2/1 (two weeks)
- Due to the method used for information on Web inquiries and access to .pdf files (where only the top positions are recorded), the number of visits made to the positions lower down in the ranking is unknown. There are consequently no figures for certain months and the resulting figure may appear lower than previous years, even though this was not the case.







From the figures obtained and expressed as percentages, a significant difference can be seen in virtual user inquiries when compared to reading room and remote users user inquiries. This was due to the fact that, in both web site inquiries and .pdf file access, users can access information an unlimited number of times, and are counted each time they do so. For other inquiries, only the

visit, e-mail or phone call is counted, one per user, despite the requested information requiring unlimited material for consultation. This explains the sizeable difference. In any case, whatever the route of the inquiry, our goal is for users to obtain the necessary information with an efficient response and for the inquiry's waiting time to be as short as possible.

Over the course of 2004, the CDI took special care to keep the bibliographic collection up-todate. Apart from the historical heritage of integration in Latin America and the Caribbean, the aim was for the site to continue to be recognized for its specificness, and for those interested in the subject to go on choosing to consult it as they have done since its inauguration 40 years ago.

To this end, it makes increasing use of available technology. Besides the printed collection, this provides it with electronic documents following the development and dynamics of the different integration processes.

Continuing its assistance work, the CDI carried out information searches, compilation and retrieval of the material for the *Monthly Newsletters*, and also prepared the *Analytical/Thematic Indices* of newsletters Nos. 90 to 101 in both Spanish and English. These may be consulted at the following web site: <u>http://www.iadb.org/intal/publicaciones/icm.htm</u>

Positive feedback was received about the usefulness of the thematic index.

The *Recent Acquisitions* listings were also updated. Due to the large amount of incoming material, it was necessary in certain months to perform two updates per month. Registrations totaled 546, 60% of whom have a link to the full text: http://www.iadb.org/intal/cdi/adquisiciones.html

The listing of links to *Periodical Publications* was updated, incorporating new links and adding the changes arising from existing ones: 108 links in all. http://www.iadb.org/intal/cdi/periodicas.pdf The *Bibliographic Listings* were updated with the material incorporated in the CDI on the following integration blocs: MERCOSUR, FTAA, NAFTA, ANDEAN COMMUNITY, CARIBBEAN REGION, and CENTRAL AMERICA.

It became obvious over the period that many users consult the listings on blocs and contact the CDI later (generally via e-mail). This means that each inquiry is personalized, targeting individual users' specific requirements.

In terms of technical processes, 1,700 entries were made in the INTEG database (books and documents, INTAL; periodical publications, KARDEX; Documents of International Organizations, DOCINT).

The database is online and is updated daily. Many users enter the database to make inquiries and establish personal contact with the CDI. This means the added value of personalized responses. http://www.iadb.org/intal/intalcdi/integ.htm

The Coordinator of the CDI took part in the IFLA International Libraries Meeting, held for the first time in Latin America in August. The World Library & Information Congress was sponsored by the International Federation of Library Associations & Institutions (IFLA), and took place in Buenos Aires with almost 3,000 participants, mostly specialists from overseas. A large number of very interesting reports were presented, and the event was extremely useful in disseminating the activities undertaken and the information services provided by INTAL. http://www.ifla.org/IV/ifla70/prog04.htm

Throughout the year, weekly issues of the *Informative Bulletin* were prepared with press cuttings on Integration and Trade taken from Argentinian, Brazilian and Chilean newspapers, in both printed and electronic format.

The CDI supervised the scanning of the journal, *Latin American Integration*, which will be pasted on INTAL's web site in .pdf format for free and open access by any interested parties. Individual and institutional authors' indices were also compiled, as well as subject indices to make the search for information more flexible and easier to access.

In terms of information systems, the modernization and updating of the Base de Estadísticas de Comercio Exterior (DATAINTAL: Foreign Trade Statistics Database) stands out. The system's new version 4.1 on CD-ROM provides a modernization of DATAINTAL inquiry options and technical and content features. The system contains export and import statistics for American countries by country of origin and destination in volume and value according to the tariff nomenclature used by each country. In addition, a new version of DATAINTAL is available on the Institute's web page, providing a significant advance in terms of technology and content compared to earlier versions.


The online Base INTAL-MERCOSUR (BIM: INTAL-MERCOSUR Databse) was continually updated, including the basic legal instruments of the integration process, as well as the resolutions, decisions and directives of the respective executive and technicals bodies.

Mention must also be made of the database of Instrumentos Jurídicos de Integración Económica en América Latina y el Caribe (Legal Instruments of Economic Integration in Latin America and the Caribbean), containing a compendium of relevant legal instruments for the integrationist process, and registering a growing number of online inquiries. This is due to its update dynamics, reflecting the constant evolution in the region in this field.

Regarding publications, apart from the continuity of INTAL's usual series, there was intense research activity, reflected in the Series INTAL/ITD, at the level of both working and dissemination papers. A new series of technical publications was also created, relating to works produced as part of the Special Initiative for Trade & Integration, coordinated by the IDB's

Integration & Regional Programs Department. In addition, the update of the Catálogo INTAL 2000-2004 (2000-2004 INTAL Catalog) was continued for all the Institute's publications, databases and information systems to December 2004.

In conclusion, in addition to these publications, the distribution of titles published by the Institute in previous periods was continued, as were the reports or documents presented in its Forums & Special Events, in both printed and digital format on INTAL's web page. Below is a graph showing the significant growth in this area since 2001 as compared with previous years.
