A. Brief description of the objectives of the project

- The objective of the proposed operation is to strengthen the institutions responsible for 1.1 providing water and sanitation services in Port-au-Prince and conduct priority rehabilitation of the water network, expand services and implement sanitation solutions in Port au Prince in a sustainable manner in order to improve access to water and sanitation. The proposed operation will have three components: Component I: Institutional strengthening of CAMEP and DINEPA, which will finance the contracting of an international water utility ("advisor") under a not-for-profit operational assistance contract to assist CAMEP in managing the potable water network. The advisor will carry out the following activities: (i) conduct day-to-day administration, operation and maintenance activities; (ii) reestablish basic IT, administration and commercial systems and policies; (iii) prepare and implement investment programs with the approval of DINEPA; (iv) prepare pre-feasibility and feasibility studies; (v) assess viable options for sanitation and conduct the corresponding studies; (vi) train CAMEP personnel; and (vii) transfer knowledge to DINEPA and CAMEP staff. Under this item, a monthly payment to the advisor will be financed. The advisor's remuneration will consist of a fixed monthly fee for a period that could extend to 36 months and will cover solely its costs.
- 1.2 An additional item that will be financed is the training to the CAMEP and DINEPA staff. As part of its contract, the operator will have an obligation to transfer knowledge and train CAMEP and DINEPA staff during the length of the management contract.
- 1.3 Lastly an item will finance staff reassignment and productivity activities. This item will therefore include the design of an appropriate rationalization package to be agreed upon with workers, and will provide incentives for early retirements and retraining; Component II: Potable water and sanitation investments, which will finance the following

activities: (i) the repair of damaged reservoirs as a result of the earthquake or lack of maintenance; (ii) the rehabilitation of pumping stations and water mains; (iii) the protection of spring catchments; (iv) the repair of water leaks; (v) the provision of water to areas of temporary resettlements; (vi) the installation of macro meters; (vii) the purchase of generators; (viii) the installation of water kiosks where individual connections are not viable; and (ix) the expansion of the service where possible. As part of this component, studies will be carried out to: (i) identify priority repairs and works that need to be carried out on the distribution network; (ii) identify marginal areas that remain viable for water distribution. DINEPA will continue ensuring the provisioning of water to temporary settlements and intends to progressively replace the provisioning of water through expensive water trucks with water delivered by the CAMEP network when possible.

1.4 With respect to sanitation, this component will finance: (i) a diagnosis of the situation with respect to sanitation in Port-au-Prince; (ii) the preparation of a master plan for a sewerage system in the center of the capital; (iii) the evaluation of alternative systems for sanitation in other areas; and (iv) communication and outreach programs for hygiene education. The advisor to be contracted by DINEPA will be requested, as part of its contract, to assess viable options for sanitation and conduct the corresponding studies as well as the implementation of the selected solutions. Component III: Control of Lymphatic Filariasis (LF) and Soil Transmitted Helminthes (STH): This component intends to build upon the reduction of risks granted by the provision of water and sanitation services and by the hygiene education measures to support the control of LF and STH in the areas of Port-au-Prince benefitting from the project and complement the activities of the Social Protection and Health division (SPH) of the Bank. It will finance: (i) Annual campaigns of mass drug administration (MDA) with Dietilcarbamacine and Albendazol for the general population; (ii) Comunication and education on hygiene, STH and LF transmission and prevention; and (iii) monitoring and evaluation activities. The execution and evaluation mechanisms will be the same as the ones used by the SPH division.

B. Procurement plan

The procurement requests will follow ex-ante reviews. Procurement of works, goods and services as well as the contracting of consultants will be governed by Bank Policies for the Procurement of Goods and Works and for the Selection and Contracting of Consultants (GN-2349-7 and GN-2350-7) and will be complemented with the OP-387-1 Disposiciones Especiales sobre Adquisiciones para atender la Emergencia causada por el terremoto del 12 de enero de 2010 en la República de Haiti¹. The procurement plan prepared in collaboration with DINEPA is presented in Annex III. The project team has identified a firm that will be contracted directly to elaborate the contract between the advisor
