Summary:

A number of Panamanian organizations and community representatives submitted a complaint expressing social and environmental concerns with regards to the Pando-Monte Lirio Hydroelectric Energy Project (the Project), financed by IADB, IFC (International Finance Corporation), CAF (Andean Development Corporation), and other private investors. After a detailed review, this Ombudsperson has determined that the complaint is eligible for the Assessment and Consultation Phases under the Mechanism¹.

I. Background

On March 12, 2010, the Mechanism received a complaint filed by 16 organizations of farmers, environmentalists, producers, religious and social welfare groups from the Province of Chiriquí, in Panama. The complaint raised a series of environmental and social concerns regarding the Project. This is a Non Sovereign Guarantee loan of 40 million dollars approved by the IADB Board on December 9, 2009.

The complainants highlighted the potential cumulative impacts that may result from the development of all hydroelectric projects in the Chiriquí River Basin, some of which have not started construction and/or do not receive funding from the IADB. Examples of impacts mentioned by the complainants include

damage to the environment, the quality of water for human consumption and local agriculture, the need to maintain the ecological flow² without impacting the river's fish and animal species, etc. Concerns also include lack of a participatory consultation process with communities, possibility of flooding communities downstream and limited community access to water.

The same complaint was logged with the IFC. The IFC has already determined the complaint's eligibility for the consultation process under its policies and procedures.

II. Eligibility Analysis

The Ombudsperson's consultation process starts with the Eligibility Determination to then move to the Assessment Phase, and finally to the Consultation and Mediation Phases, if so agreed by all parties.

As part of the Eligibility analysis, an initial dialogue with the Project team is established, and information on the complaint, complainants and the relevant project (s) is gathered. The results of such an analysis are expressed in the table below.

As this case is also being addressed by the IFC, the Mechanism and the CAO have agreed to conduct a joint consultation/ mediation process to the extent possible and in compliance with the norms and policies of the respective institutions. A separate agreement to reflect details of this collaboration is under preparation.

III. Initial consultation with Management

The ICIM's policy calls for an initial consultation with Management to learn what the status of the issue at hand is, confirm that the project team and/or management and/or the relevant country office have been made aware of the complaint, verify the steps taken by the requester to bring this issue to the attention of the Bank, and learn more about the operational response thus far. In this case, both the project team and the country office were contacted and are already collaborating with this process.

IV. Conclusion

In line with the ICIM Policy, the Project Ombudsperson has determined that the complaint related to the Pando-Monte Lirio Hydroelectric Energy Project (PN-L1054) is eligible for the Consultation Phase.

The Consultation Phase starts with an Assessment by the Ombudsperson. The purpose of the Assessment is to work with the complainants, management and any other interested stakeholders to identify on the ground and clarify the issues raised by the complainants, gather information on the various points of view and help stakeholders determine whether and how they may be able to resolve the issues raised.

The Assessment is limited to a maximum of 120 days, but may be completed more quickly. In this case, the CAO has already completed its assessment, and – after a thorough review - this Ombudsperson considers the CAO's assessment as adequate to comply with ICIM's requirements, and to enable the Mechanism to move to the Consultation Phase jointly with the CAO. Additional information, if needed, will be gathered during the preparatory meetings. CAF, as a project co-financier, has also been invited to participate in the Consultation Phase.

Although a complaint may meet ICIM's eligibility criteria, **this does not imply** any judgment on the part of the ICIM of the merit of the issues raised in the complaint.

Within the next two (2) business days, the Executive Secretariat will post the notice of registration on the Registry and notify the Requester.
