#### Information System on Trade and Integration developed by the **Integration and Trade Sector (INT)**

As from November 2013, administration and management of the system was delegated to INTAL. In late 2014, the process of redesigning the graphical user interface and migrating many functionalities to a data warehouse began. Nine integration and trade indicators were included. #### Basic Instruments of Economic Integration in LAC (IJI)

A compilation of basic legal texts concerned with regional economic integration in Latin America and the Caribbean, published by INTAL since 1992. This information is continuously updated to keep up with the intensive activity in the field of integration agreements in the region. In 2014, frequency of content updates was changed from a quarterly to a monthly basis. In addition, the dates of signature and entry into force of the agreements were surveyed. 
**DataINTAL** A system of foreign trade statistics for Latin American and Caribbean countries and other countries in the hemisphere published on the Internet by INTAL, providing unrestricted and free access to highly disaggregated data from national sources for most of the countries for the period 1992-2013.

Throughout 2014, the review and revision of the historical series continued, validating the information in the system against official sources. Special emphasis was placed on keeping trade data current so as to have up-to-date information in the first quarter of 2015.


# Specialized Information Source

The CDI identifies, compiles, organizes and disseminates information on integration, trade, infrastructure and related topics —mainly focused on Latin American and Caribbean countries— by means of readily accessible and user-friendly products and services. Over the last few years, the CDI has remarkably enlarged its collection of open access, electronic full texts, including material produced not only by INTAL and the Bank but also by other specialized organizations. 

In 2014, the complete collections of *Boletín de Información Legal* (Legal Information Newsletter) and *Boletín sobre Inversiones y Empresas Latino-americanas* (Latin American Companies and Investments Newsletter) were digitized.

This system includes access to 661 websites, a 40% increase (191 websites) compared to 2013. In addition, the data of the institutions included was updated.




#### **IIRSA Repository**

Jointly developed by IIRSA Technical Coordination Committee (CCT) and the CDI with the aim of providing open access to documents produced by or related to IIRSA and to physical integration in general.

The repository preserves and provides full-text access to IIRSA's document collection in electronic format in a link that is stable in time. In 2014, 15 documents associated with IIRSA and UNASUR meetings were added, accounting for a 6.6% increase in the collection.



#### **Latin American Inequality in the Long Run**

INTAL Auditorium, Buenos Aires, Argentina, December 3-5, 2014

Luis Bértola (Universidad de la República, Uruguay) and Jeffrey Williamson (Harvard and Wisconsin University), together with the Inter-American Development Bank (IDB), the World Bank (WB) and the United Nations Economic Commission for Latin America (ECLAC), invited economic historians focused on the study of long-run inequality trends, and economists focused on the study of recent trends. INTAL was responsible for the whole logistical organization of the event.

#### CALL FOR RESEARCH PROJECTS

A total of 65 research proposals were received, from which 4 projects were selected, one for each of the following subject areas: Value Chains and Natural Resources, Climate Change and Integration, Renewable Energy, and Standards and Market Access.

The call was answered by 159 researchers from 43 different centers around Latin America and the Caribbean, including: Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Ecuador, El Salvador, Guatemala, Guyana, Honduras, Mexico, Nicaragua, Paraguay, Peru, the Dominican Republic, Trinidad and Tobago, Uruguay, and Venezuela.

#### **IDB/INTAL - RED SUR**

INTAL, from the Integration and Trade Sector, and the South American Network on Applied Economics/Red Sur put out two calls in 2014, namely:

- 1) A call for research projects by researchers / research centers throughout Latin America and the Caribbean, focused on possible trends in the international arena over the next ten years, identifying opportunities, challenges, and alternatives for the countries of the region.
- 2) A call for a new edition of the Young Economists Award in order to promote the integration of young people into the field of economic research and knowledge creation in areas of interest to regional and global integration.

A committee made up of INT/INTAL and Red Sur members was in charge of the selection of the works.



#### YOUNG ECONOMISTS

A total of 27 research proposals were received from close to 40 young economists in Latin America and the Caribbean (Argentina, Bolivia, Brazil, Colombia, Ecuador, Paraguay, Peru, Dominican Republic, Trinidad & Tobago, Uruguay, and Venezuela). The jury singled out two projects in the categories of "Climate Change and Integration" and "Renewable Energy," deciding, in this edition of the Award, to declare the category of "Value Chains and Natural Resources" void.

## Initiative for the Integration of Regional Infrastructure in South America - IIRSA -

Intergovernmental forum for technical discussion and cooperation among the Union of South American Countries (UNASUR) Member States.

Its main purpose is to promote physical integration development in South America by fostering transport, energy and communications infrastructure development from a regional perspective, under an equitable and sustainable territorial development plan. Its work plan is governed by the Infrastructure and Planning Council (COSIPLAN), one of the sectoral councils at ministerial level of UNASUR.

IIRSA is supported by the IDB, CAF and FONPLATA, which are regional financial institutions that make up the Technical Coordination Committee (CCT), and its Secretariat operates on a permanent basis at INTAL.

Main functions of INTAL as the CCT Secretariat:



Execution and monitoring of COSIPLAN-IIRSA Annual Work Plan.


# IIRSA CCT Secretariat Products





The Project Information System (SIP) is the main tool to support integration infrastructure planning and analysis containing systematized information on the COSIPLAN projects. Project information contained in the PIS is completed by the countries. The tool is constantly being improved and updated on the basis of the requirements identified by COSIPLAN.

#### **Website**

IIRSA website is the major tool for disseminating the actions of the Technical Forum and COSIPLAN.




## **Dissemination Tools**

#### **Contact Database**

A key tool for the dissemination and information strategy of the Institute as the Bank's platform for regional action, containing data on government officials, members of academia, researchers, representatives of civil organizations, and the general public interested in integration and trade issues.

INTAL makes contact with these users through its multiple activities (courses, workshops, forums, conferences, etc.) and products (publications readers, CDI and database users, etc.).
