

4.1 Visit the Extranet Portal for Retirees of the IDB Group:








4.2. Click "Log In (Access Here)" located in the RSS menu on the lower right hand side of the page. You will need to have an active account to be able to Log into RSS. To activate your account please follow the Instructions to Activate your account and access the system for the first time.










4.4 The SAP Portal will be displayed. Please press Retiree Self-Service Launchpad.




4.5 The Retiree Self Services Main Page will be displayed. Click "My Services".





Issues displaying the 1099-R in RSS

In case that you click on the Form 1099-R option (once, left click) and nothing happens, check on your browser for the pop-up windows to be allowed.


To see blocked pop-ups for a site, follow the steps listed below:

If you are using Chrome

- 1. If pop-ups have been blocked, you'll see the icon in the address bar. Click the icon to see a list of the blocked pop-ups.
- 2. To always see pop-ups for the site, select "Always show pop-ups from [site]." Then click on the "Done" button
- 3. Refresh the page by pressing F5
- 4. If the page displays a message click continue.
- 5. Proceed from step 4.5 from attached job aid.

If you are using Edge





Block pop-ups

- 2. A menu will open, choose *Settings* from the bottom of the list
- 3. Then, look for the option *Advanced Settings* and click on the button *View advanced settings*
- 4. Locate the option Block pop-ups (which will be On) and turn it off. You can turn it on for other
- 5. Proceed from step 4.5 from attached job aid.

If you are using Firefox



- 1. Click the "hamburger" menu icon (top right) to open the Firefox menu.
- 2. Click Options.
- 3. Click the Content icon located at the top of the window.
- 4. Make sure that Block pop-up windows is activated (checkbox).
- 5. Click the Exceptions button located to the right of Block pop-up windows.
- 6. You will see the Allowed Sites dialog box.
- 7. To enable the browser to recognize IDB Retiree Self-Service as trusted site and, therefore, enable pop-ups from these sites, in the Address of web site field, type the site's URL. Type: **portalsap.iadb.org**
- 8. Repeat the previous step to add other IDB trusted sites, including:
 - o idbg.okta.com
 - o iadb.org
- 9. Click Close when you finish adding the sites you want.
- 10. Click OK to close the Options dialog box.
- 11. Proceed from step 4.5 from attached job aid.




If you are using Safari

- 1. Click on Safari on the top left corner of your screen
- 2. Click on Preferences
- 3. A new window will open, click on the websites icon from the top row



- 4. Then, below, on the left column choose the *Pop-up windows* option
- 5. Next, on the right side, set these sites as Allow: iadb.org, idbg.okta.com, portalsap.iadb.org see below image as example:



- 6. Close this window
- 7. Proceed from step 4.5 from attached job aid.
