The Inter-American Development Bank (IDB) is executing the above mentioned operation. For this operation, the IDB intends to contract consulting services described in this Request for Expressions of Interest.

The consulting services ("the Services") include as the preparation of a plan for the detailed implementation of the proposed measures in the update of the Cumulative Impact Assessment. This implementation plan should, inter alia, include the resources (financial, physical, etc.) needed to implement each measure, the implementation (or not) facility, priorities, identification of funding lines for implementation Recommendations and the action plan in time (chronological) of the actions to be carried out.

Work to be provided by the firm in their usual place of work and Cap-Haitien, Haiti for a period of 6 months.

Eligible consulting firms will be selected in accordance with the procedures set out in the Inter-American Development Bank: <u>Policy for the Selection and Contracting of Consulting firms for Bank-executed Operational Work</u> - GN-2765-1. All eligible consulting firms, as defined in the Policy may express an interest.

The IDB now invites eligible consulting firms to indicate their interest in providing the services. Interested consulting firms must provide information establishing that they are qualified to perform the Services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Eligible consulting firms may associate in a form of a Joint Venture or a sub-consultancy agreement to enhance their qualifications. Such association or Joint Venture shall appoint one of the firms as the representative.
