Ferdinando Regalia is the Social Protection and Health Division Chief. Prior to this position, he served as an Advisor to the IDB Vice President for Sectors and Knowledge (2008-2009), Chief of Social Policy and Economics at UNICEF South Africa (2008-2007), Social Protection Specialist in the Sector Operations Department 2 (Central America, Dominican Republic and Mexico), and Poverty Economist in the IDB's Poverty Unit (1999 – 2006). In these roles, he led the preparation of key lending operations and technical assistance projects in social protection and completed analytical studies in the areas of poverty and social protection. Ferdinando has published in peer-reviewed journals such as Population Studies, Journal of Development Effectiveness, Economics of Education Review and Journal of Labor Economics and is the author of book chapters on social protection and result-based financing mechanisms. Ferdinando is of Italian nationality. He holds a PhD and a Masters in Economics from the Universitat Pompeu Fabra, Spain.



María Laura Oliveri is a consultant in the IDB's Social Protection and Health Division. She joined the IDB in 2013 to work for the Labor Markets and Social Security Division. She previously worked at the World Bank's Latin America and the Caribbean Human Development Department and Poverty and Equity Global Practice. She has undertaken consultancies for the International Labour Organization and the Argentinean Ministries of Economy and Health. She has experience in labor market and social protection and poverty topics in the Latin America and the Caribbean region. An Argentine national, María Laura holds a BA in Economics from Universidad de Buenos Aires and a MA from the Universidad Nacional de La Plata.

His work has been published in peer-reviewed journals such as World Development, Demography and the Journal of Comparative Economics. Pablo Ibarrarán is a Social Protection Economist at the IDB.
