The Republic of Suriname has received financing from the Inter-American Development Bank (IDB), and it intends to apply part of the proceeds to payments under the project Support to Improve Sustainability of the Electricity Service, for the Civil Works to Upgrade of Substation building C.

The EBS now invites sealed bids from eligible bidders for the Civil Upgrade of Substation C, located on the corner of the Pluto- en Aidastraat. The construction period is scheduled for 7 months.

Bidding will be conducted through national competitive bidding procedures as specified in the Inter-American Development Bank's Policies for Procurement of Works and Goods financed by the Inter-American Development Bank GN 2349-9 (current edition), and is open to all eligible bidders as defined in the policies.

Interested eligible bidders may obtain further information from Ms. R. Patandin and request an electronic copy of the bidding documents on the submission of a written application to idb.projects@ebs.sr, starting from Thursday 4th of August 2016. The documents will thereafter be sent electronically.

All bids including the bid security must be delivered to the address below by 12:00 PM (GMT 15:00) on Friday, September 16th, 2016. Electronic bidding shall not be permitted. The bids will be opened by 12:05 PM (GMT 15:05) on Friday, September 16th, 2016, in the presence of bidders' representatives, who choose to attend, at the address below. Late bids will be rejected.

A bid security of SRD 50,000.00 - Fifty thousand Surinamese Dollars, must be submitted and delivered to the address below at the same time of the bid submission.

The site visit will be held at the project site Substation C, located at the corner of Pluto- and Aidastraat, on Tuesday 16th of Augustus 2016 at 09:00 AM (GMT 12:00).
