This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue no. IDB1858-12/14 of December 02, 2014

The Government of the Cooperative Republic of Guyana has received financing in the amount equivalent to sixteen million eight hundred and thirty eight thousand two hundred and fifty United States dollars (US\$16,838,250) from the Inter-American Development Bank and ten million six hundred and seventy five thousand euros (EUR 10,675,000) from the Caribbean Investment Facility (CIF) of the European Union (EU), and it intends to apply part of the proceeds to payments for goods, works and services to be procured under the Water Supply and Sanitation Infrastructure Improvement Program.

The Guyana Water Incorporated now invites sealed bids from eligible and qualified bidders for **Design, Supply, and Installation for the Rehabilitation and Expansion of Water Treatment Facility at Shelterbelt, Georgetown**

The construction period for the project is 24 months plus 12 months defects liability period.

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Inter-American Development Bank's Policies for the Procurement of Works and Goods GN-2349-9. Bidders from the Bank Member countries will be eligible, as well as bidders recognized as eligible by the European Union under its applicable regulations on procurement.

Interested eligible bidders may obtain further information and inspect the bidding documents at Guyana Water Incorporated at the address given below from 8.00am to 4.30pm, Mondays to Thursdays and 8.00am to 3.30pm on Fridays.

A complete set of Bidding Documents in English may be requested by email from the address: procurement@gwi.gy or purchased at the address below upon payment of a non-refundable fee of Five Thousand Guyana Dollars (G\$5,000.00). The method of payment will be by certified cheque or cash payable to Guyana Water Incorporated. Bidders will have the option of receiving the Bidding Documents electronically or by uplifting a hard copy from the Office at the address below.

Bids must be deposited into the **Tender Box located at the National Procurement and Tender Administration Board, Ministry of Finance, Main and Urquhart Streets, Georgetown on or before TUESDAY, September 27, 2016, at 9:00hrs (9:00am)**. All bids must be accompanied by a "Bid Security": GY\$15,288,000.00, or the equivalent amount in a freely convertible currency. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders or bidders' representatives and anyone who choose to attend.
