The Inter-American Development Bank (IDB) has approved Loan Contract 3684/OC-BL for BELIZE for a total amount of US\$10,000,000.00. These resources are targeted to finance Solid Waste Management Project II, which shall be implemented by the Solid Waste Management Authority (SWaMA), Ministry of Natural Resources during a period of sixty (60) months.

The main objective of the project is to support Belize in its efforts to reduce environmental pollution through the improvement of solid waste management practices in northern and southern Belize and Belmopan. Specifically, the project will finance investments to improve solid waste transport, recovery, and final disposal in towns and nearby villages in the Northern (Orange Walk and Corozal) and Southern (Stann Creek and Toledo) Corridors and in Belmopan, and to strengthen SWaMA as the lead agency in the waste management sector. The project's implementation includes: Component 1: Investments to improve solid waste management: (i) closure of six dumpsites including the acquisition of land in those sites where the land is not owned by the Government of Belize; (ii) construction of six transfer stations – sorting facilities; (iii) construction of a new cell at Mile 24 Regional Sanitary Landfill; and (iv) final designs and supervision of civil works. Component 2: Institutional Strengthening and Capacity Building. This component is aimed at ensuring the cost recovery of the entire system, implementing public education and awareness programs and improving the management of waste streams other than MSW.

The Specific Procurement Notices (SPN) for bidding shall be published in UN Development Business, the Inter-American Development Bank's website, SWaMA's website and local newspapers, pursuant to the Procurement Plan published on <a href="www.iadb.org">www.iadb.org</a> and <a href="www.belizeswama.com">www.belizeswama.com</a>. Procurement shall include goods, works, services other than consulting services and consulting services for infrastructure and consultancies.

The SPN for bidding as is the case shall be published according to IDB Policies.
