The Government of Guyana/Ministry of Natural Resources has received financing from the Inter-American Development Bank (IDB), toward the cost of the Forest Carbon Partnership Facility Project in Guyana- ATN/FP-14161-GY, and intends to apply part of the proceeds for consulting services to undertake the **Consultation and Stakeholder Engagement on REDD+ & Readiness Activities in Guyana**.

The consulting services ("the Services") include:

- a) Develop a Stakeholder Consultation and Engagement Strategy and Action Plan.
  - Conduct an analysis of stakeholders and develop a stakeholder map.
  - Undertake Baseline Survey of Stakeholder Awareness, Knowledge and Attitudes
  - Assess current Stakeholder Engagement processes.
  - Develop the Communication and Outreach Strategy
  - Develop Action Plan for communication and outreach strategy
  - Develop a monitoring and evaluation system
  - Develop Communication and Outreach Materials
- b) Conduct National Consultation and Outreach Activities Develop a joint plan for building on strengths and closing gaps.

The work of the Consultants is expected to be conducted over a **24 month period**, commencing in **April 2017**.

The Ministry of Natural Resources now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

Short lists shall comprise six firms with a wide geographic spread, with no more than two firms from any one country.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: [Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank](#) GN-2350-9 and is open to all eligible bidders as defined in the policies.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the short list, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of Joint Venture, the nationality of the firm appointed to represent it.

A Consultant will be selected in accordance with the Quality and cost-based selection (QCBS) method set out in the [Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank](#).
