# **Status Update**

The COVID-19 pandemic affected the prioritization and organization of IDBs portfolio in Bolivia and operation BO-L1204 waspostponed until2024. Despite this circumstance, the development of plan for the execution of a new operation (BO-L1219) has been completed in 2022, the technical products were delivered and the objectives of the TC were achieved. The maintenance modeldeveloped has been adopted by the MoH and implemented at the Madre Obrera Hospital (Llallagua) and will be implemented at theSan Salvador Hospital (Ocuri). Likewise, the proposals for improvements in the Program against Malnutrition which this TC financed are being implemented on a pilot basis in 15 health networks within the operation BO-L1198.

Advances In Execution: A comprehensive maintenance plan, with its detailed budget, has been prepared for future implementation at the El Alto Sur, Madre Obrera de Llallagua, Potosí, and San Salvador de Ocuri hospitals. The plan is expected to be financed through operation BO-L1219, which is awaiting elegibility. In the meantime, maintenance activities are being implemented at the Madre Obrera hospital and will soon be implemented at the San Salvador hospital with support from BO-T1380.
