Supply and Installation for One (1) Atmospheric Water Generator.

1. The **Cooperative Republic of Guyana** has received a loan from the Inter-American Development Bank toward the cost of **Support to Safety Nets for Vulnerable Populations Affected by Coronavirus in Guyana (Component 2)**, and it intends to apply part of the proceeds of this loan to payments under the Contract for the **Supply and Installation for One (1) Atmospheric Water Generator**.
2. The **Ministry of Education** invites sealed Bids from eligible Suppliers for the **Supply and Installation for One (1) Atmospheric Water Generator**. The RFB will be conducted through the International Competitive Bidding (ICB) procedures specified paragraphs 2.1 of the Inter-American Development Bank's Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN-2349-15 approved by the Board of Executive Directors of the Bank on 2nd of August 2019 and effective 1st of January 2020, and is open to all bidders from Eligible Countries as defined in the

bidding document.

3. Interested bidders may obtain further information from **Ministry of Education-Project Implementation Unit, Project Coordinator** at the **address 1** given below from **8:30 hrs. to 16:30 hrs. from Mondays to Fridays**.
4. Qualifications requirements include: The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement: (a) Furnish documentary evidence by providing copies of contracts, award letters, invoices or similar to demonstrate that they are a supplier of machinery or equipment within the past three years i.e. 2020, 2021 and 2022 with a minimum average value of Ten Million Guyana Dollars.
5. A complete set of the bidding documents in *English* may be obtained by interested bidders on the submission of a written Application to the address (1) below from Monday, March 13, 2023. Bidders are required to indicate an e-mail address in their application, where the bidding package and any amendments to the bidding document can be sent, and received by bidders.
6. Bids must be delivered to Address 2 below at or before **Tuesday, April 25, 2023 at 09:00hrs local time**. Electronic bidding *shall not* be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person or on-line at the Address 2 below at **Tuesday, April 25, 2023 at 09:00hrs**.
7. Bids *shall* be accompanied by a *Bid-Securing Declaration as required in Section 19.1 of the Bid Data Sheet*.
