Status Update

The Technical Cooperation DR-T1176 closed at the end of 2022 with all contracted consulting deliverables received in compliance. The multidisciplinary team of consultants presented the final result of their work in a supervision mission held at the end of November in Santo Domingo, showing the complete design of innovative programs that reflect the best international practices in comprehensive care for adolescent and adult women. The consultancies financed by this technical cooperation have designed the program for comprehensive care for teenage mothers and pregnant teenagers; the program for the prevention of teenage pregnancy at the community level; the program for labor insertion and support for women entrepreneurs; as well as the creation of a visual tool for mapping vulnerability indicators that shows, in a very user-friendly way, in which provinces of the Dominican territory the greatest needs for care for women are located. With this information, the Social Policy Cabinet will be able to plan the expansion of the comprehensive care model based on evidence.

Advance in the Achievement of Outcome and Outputs

Advance in the Achievement of Outcome

1. Technical capacities to execute and lead the City of Women (CM) Program in the Dominican Republic strengthened

Each consultancy service provided by this TC has strengthened the capacity of the executing agency and the quality of the care model to be implemented by the loan. The TC has particularly strengthened capacities in 2022 in critical areas for the comprehensive care model, such as prevention and care of teenage pregnancy, case management for gender violence and digital management; but also, in project management, procurements and BIM management.

The Project Manager hired to assist the Executive Agency in order to accelerate the execution of both the loan and this TC, delivered every month and a half or two months performance reports of both operations, analyzing risks, forecasting execution data and controlling the planning tools to manage deviations and enhance opportunities. The reports focus on critical paths, as well as PMR goal achievements.

Advances In Execution: 2 Programmatic and environmental requirements assessments for the design of Santo Domingo and Santiago CEDIMujer, 1 Needs assessment of medical equipment and technical specifications for CEDIMujer Centers, and Environmental Management Assessment of the whole project. Due to the fact that the first design presented to the Bank by the Government was considered inadequate in terms of size, distribution, budget and energetic solutions, two consultants where hired with the TC in order to define a building strategy aligned with best practices in energy systems, programme and volumes. The consultants made, one for Santo Domingo and one for Santiago, the architectural strategies that where given to the firms afterwards for the project design. The needs assessment for medical equipment was made in order to identify the requirements of the specific services provided in CEDI Mujer in order to launch the international bid process that has been conducted to acquire the equipment.

Advances In Execution: Regarding the diagnosis of PPP options for Cedi-Woman. Taking into account that the Centers did not have a defined institutional architecture, it was not possible in 2022 to identify relevant PPP opportunities, therefore, with funds from a regional cooperation, the entire design of the institutional and process architecture was financed, within the framework Of which, the consultant identified the possibility of creating a trust mechanism through a Foundation associated with CEDI-Mujer with a public-private nature. This trust mechanism linked to the CEDI-Mujer Foundation may receive public and private funds, which will contribute to the sustainability and continuous improvement of the services provided by the Centers. In 2023, with funds from a new TC, the mechanism will be legally created and its operating manual will be designed.

Advances In Execution: Technological architecture and infrastructure diagnoses: these two consultancies analyzed CEDI-Mujer's software and hardware needs, allowing the identification of which programs must be developed and for which areas and which equipment is necessary to manage these programs. The consultancies prepared the technical specifications of the equipment that will be acquired by the Executing Agency and proposed a work methodology for a team of developers to adapt software for the Centers based on the clinical record of the user with CRM and ERP based on the acquisition of an open source platform.
