The operation will permit the beneficiaries to intensify their agricultural production in a sustainable manner in the Ennery-Quinte watershed. The investments foreseen will seek to stabilize critical areas of the watershed, to rehabilitate a series of small-scale irrigation systems including the recovery from post-hurricane Jeanne damages, and to intensify agriculture development through improved marketing, production and water-user group management.

BANKS COUNTRY STRATEGY

The operation is consistent with the Bank Transitional Strategy within the framework of Agricultural Intensification and support to the recovery post-hurrican Jeanne and the reduction of risk of flood in Gonaives.

OBJECTIVES

The operation seeks to increase the income and employment of beneficiaries in the Ennery-Quinte project area and at the same time reducing the risk of further flood and mudslide damage in the watershed.

EXPECTED RESULTS

The project will result in a substantial increase in income and employment in the area of the project. At the same time, it will contribute to the protection of the Ennery-Quinte watershed and lowering the risk to the direct beneficiaries and to the broader population downstream. As a project affiliated with the Agricultural Intensification Program ("PIA", 1490/SF), the results of a model of intensification in a zone distinct from the Artibonite Plain, with partially hillside production y small-scale irrigation in a smaller watershed, may well have relevance for a variety of other zones of Haiti.
