The Government of Jamaica through the Ministry of Health and Wellness *has received* financing from the Inter-American Development Bank (IDB), toward the cost of the Support for The Health System Strengthening for The Prevention And Care Management Of Non-Communicable Disease Programme, and intends to apply part of the proceeds for the procurement of goods and services to fulfill the Electronic Health Records requirements for the improvement of management, quality and efficiency of health services in Jamaica.

The Ministry of Health and Wellness now invites bids from all eligible and qualified bidders for an Electronic Health Record (EHR) Management System for 10 primary care health centers and 3 hospitals – "Electronic Health Record Implementation". The scope of the EHR requirement includes:

- Primary Care EHR,
- Hospital EHR and
- Public Health Information Management.

The successful bidder will carry out an in-depth analysis of the pilot sites, including available infrastructure, implement the system, and provide recommendation for national implementation beyond contract period, perform project supporting activities including change management, project result information dissemination and communication, and training of relevant personnel.

Bidding will be conducted through international competitive bidding procedures as specified in the Inter-American Development Bank's <u>Policies for Procurement of Works and Goods financed by the Inter-</u> American Development Bank (current policies), and is open to all eligible bidders as defined in the policies.

A two-stage bidding process will be used which will proceed as follows:

- (a) The first stage process will consist of submission of the Technical Part of the Bid only, without any reference to prices. Following the evaluation of first stage, a Bidder that has submitted a sufficiently responsive Bid may be invited to attend a clarification meeting(s), during which the Technical Part of the Bid will be reviewed. Any required specific changes, additions, deletions and other adjustments will be noted and recorded in a memorandum, or, if amendments are of a general nature, will be promulgated via an addendum to the bidding documents. Following the clarification meetings, Bidders may not be invited to submit second stage Bids, if their first stage bids contain departures from the requirements to the extent that it cannot be expected to be responsive through the 2nd stage of the bid process. All other suitably qualified and eligible Bidders shall receive invitations to submit second stage Bids.
- (b) The second stage process will consist of submission and evaluation of:
 (i), the updated technical part incorporating all changes required as recorded in the proposer-specific memorandum, and/or as necessary to reflect any Addenda to the bidding documents issued subsequent to the first -stage; and (ii), the financial part.

Bids are to be submitted electronically on the Government of Jamaica e-Procurement system. Late bids will be rejected. Bids will be opened on-line at **12:30pm, January 29, 2021.** Bidders are therefore urged to commence bid upload at least two (2) hours prior to the submission time. The Procuring Entity will not be held liable for bids not submitted on time due to late commencement of bid upload.
