The Government of Barbados through the Ministry of Maritime Affairs and the Blue Economy has received non-reimbursable technical cooperation grant in the amount equivalent to US \$500,000 from the Japan Special Fund of the Inter-American Development Bank (IDB). The Government intends to apply part of the proceeds to contracting of consulting services to be procured under the Technical Corporation for Improving Institutional Frameworks for Integrated Coastal

Zone Management, National Risk Information Planning Systems and Sustainable Climate- Resilient Coastal Infrastructure. The project will be jointly financed with The Government of Barbados. Bidding will be governed by the Inter-American Development Bank's eligibility rules and procedures.

The objective of this technical corporation is for the completion of technical studies to develop the design of an Advanced, Integrated Coastal Zone Management (ICZM) Institutional, Coastal Risk Assessment, and Sustainable Climate Resilient Coastal Infrastructure Program. This Program would contribute to effective management and sustainable development of Barbados' Blue Economy growth ambition.

The project encompasses the following three (3) components:

1. Institutional Capacity Development for Advanced and Improved Integrated Coastal Zone Management
2. Improved and Strengthened Utilization of Coastal & National Risk Assessment
3. Sustainable Climate Resilient Coastal Infrastructure.

The following is a general description of five (5) of the seventeen (17) procurements planned for the proposed programme:

- Development of a Plan and Specification of Institutional Reform for ICZM
- Development of a Draft National Plan and Work Programme for Coral Reef Restocking
- Development of a Draft National Action Plan for Ecosystem Services/National Capital Valuation
- Preparation of Behaviorally-Informed Community-Based Disaster Risk Management Plans for two Vulnerable Communities
- Pilot Project for the Governance and Economic Enterprise Models for Public-Private/Co-Management Partnerships for Marine Management Areas and Beach Management

In this program the procurement processes of contracts financed by the Inter-American Development Bank will be conducted in accordance with the [Policies for Procurement of Goods and Works financed by the Inter-American Development Bank \(GN-2349-15\)](#), January 2020 and is open to all eligible bidders as defined in the policies. Consulting services will be selected and contracted in accordance with the [Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank \(GN-2350-15\)](#), January 2020.

Specific procurement notices for contracts to be bid under the Inter-American Development Bank's international competitive bidding (ICB) procedures, will be published as they become available. For consulting services expected to cost an amount equivalent to US \$200,000 or more, a request for expressions of interest contracts will be advertised in [UN Development Business](#) and [Inter-American Development Bank's](#) Web Site and the Barbados Nation and the Barbados Advocate News Paper.
