2. Technical Architect and Systems Integrator (1 Consultant)	The consulting services includes providing all necessary expertise and support to ensure that the datacenter hardware and software that is provided by the Ministry of Health IT Staff is properly configured to ensure the successful completion of all data mapping activities, configuration of the HIE and the software development necessary to meet the objectives of the ITSS within its allocated time.
3. Healthcare Integration Engineer (HIE) (2 Consultants)	The consulting services includes providing all necessary expertise needed to configure the HIE and develop and build the necessary interfaces required to connect all data points from SIP Plus and the LIS to be matched to the HL7 FHIR equivalent for each patient for storage on the FHIR Server.
