The Republic of Suriname has received financing from the Inter-American Development Bank (IDB), toward the cost of the Paramaribo Urban Rehabilitation Program (PURP) and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include activities related to component I of the project Urban Interventions:

The incorporation of legal provisions into the existing legislation that will enable the implementation of the

Parking Management Policy and Strategy (PMPS) and assess the existing institutions that have the potential to be the National Parking Authority (NPA). If necessary, the services will determine whether a new institution or unit with specific legal provisions is required. The service will be delivered to the Project Coordinator and/or her designee of the Project Implementation Unit (PIU) of PURP.

The duration for these Services is **six (6) months**.

The Ministry of Education, Science and Culture (MESC) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and experience as follows:

Professional experience:

- The consulting firm will provide references and credentials of at least two (2) similar works in the last five (5) years. "Similar works" refers to adaptations or amendments of acts and institutional bylaws.

The Expression of Interest (EOI) should include:

- Letter of interest from the firm.
- Proof of their legal status as a firm.
- Detailed portfolio with pictures, references, credentials of relevant projects/assignments (including date, place, size and cost of the project).
- Company Profile related to the assignment (Company structure, demonstrated experience, skills and expertise).

Short lists shall comprise firms with a wide geographic spread not fewer than five (5) and not more than eight (8) eligible firms.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: **Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank GN-2350-15** and is open to all eligible bidders as defined in the policies.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the short list, the nationality of a firm is that of the country in which it is legally incorporated or constituted.

A Consultant will be selected in accordance with the **Quality and Cost Based Selection (QCBS)** method set out in the Consultant Policies.
