II. Objective and Justification

- 2.1 This TC will support the strengthening the public labor intermediation services of the Ministry of Social Affairs and Labor in Haiti. The specific objectives are: (i) to strengthen the governance mechanism between national and local offices for the delivery of public labor intermediation services; (ii) to design an information system network blueprint required to support the governance between national and local offices for the delivery of public labor intermediation services; and (iii) to design quality standards for public labor intermediation services for youth.
- 2.2 Haiti needs to integrate young people into society and into the labor market in order to maintain social cohesion and achieve the desired level of development and growth. Labor Intermediation Services (LIS) can contribute to improve the match between labor supply and demand through services beyond the match itself and may include: (i) labor market information; (ii) job placement; (iii) training and other Active Labor Market Programs; (iv) administration of unemployment insurance; and (v) migration management. International evidence shows that labor intermediation is cost-effective

and that it helps the unemployed find better paying jobs, compared to the unemployed who use other search methods, and increase the probability of finding formal employment.

III. Description of Activities and Outputs

- 3.1 Component I. Strengthen the governance mechanism of the labor intermediation public service. US\$ 140,000. This component will finance the design of a governance mechanism for the delivery of PLIS that enable developing strategies and customize policies and programs that respond o local labor market conditions. The design incorporates both mechanisms to ensure good vertical governance (the relationship between national, regional, and local levels) as well as horizontal governance (the relationship with employers, employers' associations, education and training organizations).
- 3.2 Component II. Information Network Blueprint to support governance between national and local offices. US\$ 180,000. This component will finance the design of an information network blueprint to support the governance mechanism of the PLIS. The design should incorporate: (i) assessment of current infrastructure in the 13 regional offices; (ii) the blueprint for the network including: (a) list and technical specification of equipment; (b) equipment connection; (c) physical space requirements; (d) environmental requirements; and (e) security measures.
- 3.3 Component III. Quality standards for labor intermediation of youth. US\$ 330,000. This component will finance the design of quality standards and formalized assessment process for labor intermediation of youth considering 8 dimensions: (i) relevance to youth; (ii) relevance to employers; (iii) training curriculum structure and design; (iv) teaching strategies and resources; (v) complementary support services; (vi) career guidance services; (vii) job placement services; and (viii) monitoring and evaluation.
