RE: Non-objection for Successful Projects under the 2021 Call for Proposals for the Regional Public Good Initiative to be funded by the Inter-American Development Bank

Reference is made to the subject as captioned above.

By letter dated September 15, 2021 the Inter-American Development Bank (IDB) requested non-objection from the Ministry of Planning and Development for the Bank to proceed with funding four (4) projects that were successful in the IDB's 2021 Call for Proposals for the Regional Public Good Initiative. These regional projects that are selected for funding by the Bank and for which Trinidad and Tobago is a participating county are as follows:

1. Regional Model to Strengthen the Capacities and Enhance Coordination among Citizen Security and Justice (CSJ) Institutions to Respond to Trafficking in Persons with a Gender Perspective and an Approach to Digital Technologies –

This Regional Public Good seeks to improve countries' responses to trafficking in persons (TIP) by strengthening institutional capacities within the CSJ sector and coordinating with other sectors to combat this crime more effectively. The project is valued at US\$700,000.00. The executing agency in charge of implementing project activities is the IDB. A Steering Committee will be made up of personnel from the participating countries, represented by the respective governing bodies on the subject. These individuals will coordinate the participation of other institutions within the CSJ sector in their respective countries. For Trinidad and Tobago, the Ministry of National Security will be the primary coordinating Agency with the IDB this initiative.

2. The Digital Transformation Hub –

This project is expected to improve awareness and knowledge, capacity, adoption and management of digital technology by micro, small and medium sized enterprises that are within the digital economy in the Caribbean. The cost of this project is US\$680,000.00 and is to be implemented by the University of

the West Indies Open Campus. Each beneficiary country will appoint one representative (National Focal Point) from the institutions participating in the project to form the Project Steering Committee (PSC). The focal points will be responsible, at a national level, for facilitating project execution, and helping build consensus with stakeholders. The National Entrepreneurship Development Company Limited (NEDCO) is the local entity that will participate in the execution of the initiative and will contribute in-kind resources.

- 3. Digital Communications Campaign to Attract Foreign Direct Investment into the Caribbean This initiative is expected to enhance the competitiveness and value of Caribbean brands through a collaborative approach to attracting foreign direct investment (FDI) into the Caribbean utilizing digital platforms. It proposes the development and implementation of an online marketing campaign with a focus on investor lead generation and conversion to projects. This initiative includes the development of regional investor perception surveys, which will inform a regional digital marketing campaign. Regional promotional tools and methods for online promotion will be developed and capacity building for the partners to this project will be undertaken to ensure sustainability. An allocation of US\$610,000.00 was made for this project, which will be executed by the Caribbean Export Development Agency. There will also be a Project Steering Committee, which will include a representative or focal point from each of the participating member countries. InvesTT Limited is the local entity that will participate in the execution of the initiative and will contribute in-kind resources.
- 4. Regional Integration of the Green Hydrogen Value Chain —
  The objective of the proposal is to contribute to the decarbonization of energy services supporting the development of a regional Green Hydrogen (GH2) initiative through the promotion of the regional integration of its value chain. This project proposes to provide a Green hydrogen hub for the LAC region, develop a proposal for Harmonized Green Hydrogen Certification, and create a proposal for safety regulation for the transport of green hydrogen. This project will be Bank-executed, totalling US\$480,000.00. The execution structure will include the creation of a Steering Committee, which will have representation from all participating countries and from different sectors of the IDB. For Trinidad and Tobago, the National Energy Corporation of Trinidad and Tobago will be the primary coordinating Agency with the IDB this initiative.

The Ministry of Planning and Development wishes to commend the Bank for coordinating the 2021 Call for Proposal for the Regional Public Good Initiative. Additionally, the Ministry is thankful for the opportunities for Trinidad and Tobago to participate in the regional projects. These projects are expected to contribute to the development of various sectors of the economy. In this regard, approval is granted by the Government of the Republic of Trinidad and Tobago for the Bank to proceed with the execution and funding of the abovementioned projects.

Re: The Government of Jamaica's Letter of Request for Non-Reimbursable Technical Cooperation Support from the Inter-American Development Bank to finance the Government's Priority Areas (Technical Cooperation Pipeline 2021/2022)

As you may recall, the Government of Jamaica (GOJ) and the Inter-American Development Bank (IDB) representatives had two (2) days of Portfolio Review in relation to all past and upcoming Technical Cooperation (TC) support on September 16 and October 1, 2021 respectively. The Portfolio Review's primary objectives were to: i) discuss the overall performance of the TCs, ii) review select projects being implemented, iii) agree on the critical next steps for the management of the portfolio, and iv) reduce any existing implementation challenges.

One of the strategic agreements emanating from the TC Portfolio Review was to create a more structured process for the design and development of the TC Pipeline of projects on a yearly basis. It is anticipated that this process will allow for: i) reduced transactional costs which will in turn promote greater efficiency in developing TC projects, ii) strategic alignment of available funding from the IDB with respect to priority areas for the GOJ, iii) early initiation with the Bank with respect to securing scarce grant resources and iv) improved programming of TC funding around both the GOJ and IDB budget processes.

In light of the foregoing, and the endorsement of the Planning Institute of Jamaica (PIOJ), the Ministry of Finance and the Public Service (MOFPS) hereby submits for consideration, an indicative first list of concepts for Non-Reimbursable TC support (see attachment) which will serve as the official pilot of a structured process for the design and development of future TC projects.

We wish to outline two (2) conditions to this new structured processing arrangement:

- i. the Bank should ensure that the MOFPS, PIOJ and the relevant Ministries, Departments and Agencies (MDAs) are involved/included in the design, preparation and coordination of the respective projects in order to facilitate full alignment with the GOJ's strategic priorities. Also as was mutually agreed regular monitoring meetings are to be convened to bridge any unforeseeable gaps; and
- ii. there may be instances in which the GOJ deems it fit to submit separate special requests to the Bank for Technical Assistance (TA) on an ad hoc basis, and as such we would appreciate the Bank's flexibility in this regard.

The MOFPS anticipates the IDB's favourable consideration of this indicative first list of concepts for Non-Reimbursable TC support which will deepen the collaboration between the GOJ and the Bank, and will also assist in enhancing the request and approval process for future TC support.

#### Re: Supporting Digital Transformation amongst Caribbean Firms

The Belize Trade and Investment Development Service (BELTRAIDE) is committed to fully support and participate in the execution of the regional project "The Small and Medium Enterprise (SME) Digital Transformation Institute" as proposed for financing under the Initiative for the Promotion of Regional Public Goods (RPG).

The below proposals within the RPG are a priority for our country because digital transformation within the private sector is crucial for the competitiveness and growth of the economy.

- A coordinated regional resource for curated, standardized, and quality digital capacity building offerings to Caribbean SMEs
- Data generation and data sharing protocols on digital capacity needs
- A methodology to increase digital adoptions amongst SMEs such as the digital innovation vouchers pilot.
- Data-driven action plan for a supportive innovation policy framework to ensure sustainability and integration of firms into innovation ecosystems

Although the use of digital technologies allows companies to improve their competitiveness and resilience, there exists a knowledge gap regarding what digital technologies are available for firms and how they can improve their digital maturity. The Digital Check-Up Self Diagnostic Tool, developed by the IDB, reveals to firms their strengths and weaknesses in terms of their digital maturity and practical steps needed to improve. Countries can utilize this tool to understand firms' needs and how to connect them to resources for adopting digital technology. Specifically, the benefits include:

• Firm visualization of results and understanding of necessary steps to improve their digital maturity (i.e. knowledge of the application of digital technology to improve their efficiency, competitiveness, and market penetration)

Anonymously aggregated and comparable data that can be used as input for national, digital
transformation strategies within the private sector, articulating the allocation of resources to
meet the known needs of firms (i.e. better understanding of the digital skills gap; thus, the
human capital needs of the private sector which can be addressed through skill accelerators
known as digital talent bootcamps, etc.), development of MSME support programs, and
better understanding the demand so as to develop/encourage the supply for such needs,
ideally at a regional level.

This letter serves to notify the Inter-American Development Bank that BELTRAIDE hereby commits to contribute in-kind, technical expertise, for the equivalent of US\$ 20,000.00. The in-kind contribution for the captioned digital self-diagnostic tool will be the following:

- 1. The appointment of a liaison that will coordinate the local team towards designing, implementing, and maintaining the self-diagnostic tool.
- 2. The appointment of an IT expert/small technical team to manage the transfer of the digital
- 3. The commitment of a team that will (i) provide input to the translation of the assessment tool (ii) guide the collection and sharing of data as per national regulations regarding data privacy (iii) analyze and communicate data results for input to national strategies, SME technical and financial support mechanisms, etc. (iv) develop a mapping of local support offerings that SMEs can tap into to support their digitalization efforts (v) promote the tool amongst the private sector and (vi) to manage and maintain the tool.

Furthermore, BELTRAIDE confirms that (i) the tool shall not seek to generate any financial profit, meaning that the access will be free of charge for enterprises and (ii) anonymized data will be shared with the IDB.

Considering the above, this organization pledges, once the objectives of the project have been accomplished, to continue promoting and supporting the development of the RPG by (i) contributing to and utilizing the virtual digital transformation institute to improve digital transformation capacity amongst MSMEs as well to (ii) continue collaborating and peer-based learning to improve the innovation and productivity of SMEs.
