

RULES AND REGULATIONS FOR THE CARTOON AND ILLUSTRATION CONTEST

- The Third Cartoon and Illustration Contest: The Future of Work (the "Contest") is open to cartoonists and illustrators that are nationals of all Latin American and Caribbean nations that are IDB members (the "Participants").
- Participants must submit works of their authorship that are original or have been published in their own name.
- Participants must fill out and submit a statement that the IDB will send them, which guarantees that the works submitted to the Contest are original and unpublished, that they own the rights of property and authorship over said works, and that these do not infringe the rights of third parties, such as intellectual property rights (the "Statement"). If this statement cannot be submitted, their works will not be considered by the jury selected by the IDB (the "Jury"). If a Participant is a minor, the minor's legal representatives must fill out and submit this Statement.
- Each Participant may submit up to 3 works.
- Works must be submitted exclusively in digital format, in color or black-and-white, in TIFF or JPG files of between 1 MB and 15 MB, with a resolution of at least 300 dpi.
- Works may be submitted, as established in these rules and regulations, through this website, until March 31, 2019 at 11:59 PM, Washington, D.C. time (EST).
- Short texts may be included in the cartoon or illustration, which may be written in Spanish, Portuguese or English.
- To maintain the Contest's relevance over time, the works should highlight ideas more than specific events related to the current political situations of countries.
- An organizing committee will be formed by 3 IDB representatives (the "Organizing Committee").
- Before delivering the submitted works to the Jury, the Organizing Committee will disqualify any works that:
 - o do not comply with the Contest rules and regulations;
 - o promote any kind of political and/or religious proselytism;

- display vulgar behaviors or expressions, or whose content is considered indecent or obscene;
- o use content that violates or infringes the rights of a third party;
- use content that may be considered defamatory, slanderous or libelous; or
- use content that promotes intolerance, racism, hatred or harm against any group or individual, or discrimination based on race, sex, religion, nationality, disability, sexual orientation or age.

IDB employees may participate in the Contest, but may not receive prizes.

Selection of winners and finalists

The winners of the Jury prize and the public prize (the "Winners") will be selected by the Jury, which will consist of a panel chosen by the IDB.

- Works that are received after the deadline or do not comply with all the requirements of this Contest will not be considered by the Jury.
- The Jury will choose up to 10 finalists, from which it will select a winner.
- In addition, the Contest will recognize the public's favorite work, which will be chosen in the following manner: the finalists' works will be submitted to an open vote by the general public, who will select and recognize their favorite through the IDB's Facebook page. The works of the finalists will be posted the IDB's Facebook page between April and May 2019. The selection criteria will be the number of "Likes" received on Facebook (once the Contest is closed, more details will be given regarding the finalists).
- The results of the Contest will be announced publicly on the IDB's official website, on Twitter and on Facebook no later than June 30, 2019. The finalists will be notified to the e-mail address they indicated in their contact information. If the information submitted by the candidate does not allow the IDB to contact them, they will lose their quality as a finalist and/or winner, their work will be disqualified and they will not be allowed to present any type of complaint.
- In order to be declared a finalist, the selected Participants must be able to demonstrate, at the request of the IDB, that they are citizens of a Latin America or Caribbean nation that is an IDB member, and that they are 18 years of age or older. If unable to prove this, the Participant will not be selected among the finalists.
- In order for a minor to be declared a finalist, the legal representatives of the minor must expressly authorize the minor's participation in the Contest, in accordance with the provisions of these Contest Rules and Regulations.
- The Jury may decide not to award a prize if it considers that none of the works submitted is of sufficient quality.
- The jury's decisions are not appealable.

- The IDB will only notify the finalists and winners, and their names will be published on the IDB's official website.
- By entering the contest, all participants agree not to make the IDB or the Jury responsible for any claim, cost or expense related to, but not limited to, damages arising from their participation in this contest or related activity, use and maintenance of the prize awarded for this contest. The IDB will not be responsible for any damage, accident or detriment to the finalists, including, among others, damages, illnesses or accidents suffered during flights, stay in the stopover or destination country, presence at scheduled activities, loss of luggage or other situations that may occur during the trip. The IDB will not be responsible for or reimburse any expenses resulting from the occurrence of illnesses or accidents during the trip. The finalists will receive additional information about the terms of the trip and certain restrictions may apply.
- Participants in this contest expressly authorize the IDB, solely by participating in this
 contest, to disseminate their names and nationalities, in the manner that the IDB deems
 appropriate, unless expressly requested by the Participant.

Prizes

The Jury selected by the IDB will choose a total of up to 10 finalists, from which it will select two winners: one chosen by the Jury and another chosen by the public, in accordance with the provisions of the Contest Rules and Regulations.

The finalists will receive:

- A certificate accrediting status as a finalist; and
- Exhibition of works at the IDB headquarters located in Washington, D.C., and in different physical and virtual IDB spaces, including both its headquarters and its 26 country offices.

Prize for the winner chosen by the Jury

The winner chosen by the Jury will be invited to participate in an IDB event (the "Trip") in Washington D.C., USA, or in any of its member countries, under the following terms:

- The IDB will cover travel expenses from the winner's city of origin to the city in which
 the event is held (round-trip air ticket and/or bus or train ticket, in economy class), as
 well as lodging, per diem for food and local transportation for 2 nights.
- The winner will be solely and exclusively responsible for processing, obtaining and paying for passports, visas and any other document necessary for the trip included as the prize for this contest. In addition, he/she will be responsible for all travel costs not included in these Contest Rules and Regulations.
- The IDB will not be responsible for a refusal or rejection by the destination country's consulate in granting the necessary visas and/or permits, all of which will be the exclusive risk and responsibility of the winner.

In order to receive the Trip as a prize, the winner chosen by the Jury must be able to demonstrate, at the request of the IDB, that he/she is 18 years of age or older, and that he/she meets the other requirements established in the Contest Rules and Regulations.

In addition, the winner chosen by the Jury will receive a large professional illustration device.

Prize for the winner chosen by the Public

A second winner will be chosen from among the finalists, in the category of "public's favorite," which will be selected through a Facebook survey in the terms set out below. The winner in this category will receive a large professional illustration device as prize. In the event that the same work is the winner of both the Jury and public categories, the "public's favorite" prize will go to the work that obtains the second largest number of votes.

Reproduction rights and disclaimer

The IDB reserves the right to publish the selected and awarded cartoons and illustrations on the IDB's official website for an indefinite period of time, as well as in other printed publications or other media decided by the Bank.

The Participants, finalists and winners expressly authorize the reproduction and dissemination of the content of their cartoons and illustrations for exhibition, promotion and publicity, of the IDB events on all types of media. They also authorize the IDB to take photos and make sound and/or image recordings of their participation in the events associated with the contest and to disseminate such materials, either live or recorded, in whole or in part, on all types of media known or unknown to date.

The cartoons and illustrations will only be used by the IDB in events and communications, whether internal or external. This dissemination will be made in different media, including reproduction in posters, catalogs, postcards, calendars, books, internet or videos.

All opinions expressed by the artists in the framework of the Contest, including those expressed in the publications described above, belong to the authors themselves and do not necessarily reflect the point of view of the IDB, its Executive Board, or the countries it represents.

Warranty and compensation

Participating in this contest implies the total acceptance of its conditions, in their entirety, including any modifications. All works submitted with incomplete, incorrect or falsified information, or information that is in violation of these rules and regulations, will be considered null and void, even after a prize has been awarded. Any false statements by Participants will exclude them from the contest or, if applicable, result in the revocation of the awarded prize., without the responsibility of the IDB being compromised. In this case, the IDB will not be liable and reserves the right to take any measures it deems necessary.

The Participants will be responsible for their copyright and information submitted by the Participants and hold the IDB harmless for any mistakes regarding acknowledgment of authorship.

Each Participant will declare and guarantee, at the time they submit their works, that the cartoons and illustrations presented are original, of their own authorship and that they are the sole and exclusive holder of their rights. To the maximum extent permitted by law, the Participants agree to defend, indemnify and hold the IDB harmless from and against any claim, actions, lawsuits or proceedings, as well as any and all losses, liabilities, damages, costs and expenses (including legal fees) arising or originating from: (i) any idea or other material provided by the Participant that infringes any copyright, trademark, trade secret, trade dress, patent or other intellectual property right of any person or defames anyone or violates their rights of publicity, privacy or any other related right; (ii) a breach of any guarantee set forth in this document; (iii) any false statement made by the Participant in relation to the Contest; (iv) any breach of these Rules by the Participant; (v) claims submitted by persons or entities other than the parties to these Rules derived from or related to the participation of the Participant in the Contest; and (vi) the acceptance, possession, misuse or use of any prize or participation in any activity related to the Contest or participation in the Contest.

Applicable law and arbitration

All matters, questions or controversies relating to this Contest shall be governed by the laws of the District of Columbia, although no part of this clause or the contest rules and regulations may restrict, limit or impede any right, privilege or immunity granted to the Bank or the staff of the Bank under any national or international treaty or law.

If a controversy arises related to the contest that cannot be resolved through an amicable agreement, then, after one of the parties notifies the other of the difference or controversy, such controversy will be submitted to arbitration and final resolution by a single arbitrator. The arbitration will be administered by the American Arbitration Association, in accordance with the Commercial Arbitration Rules of the American Arbitration Association. The location of the arbitration procedure will be Washington, D.C. The language to be used in the arbitration procedure will be Spanish. The arbitrator will have legal counsel if they wish, or if one of the parties requests it. The expenses of any arbitration procedure shall be paid by the Participant and the Bank in equal parts.
